High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. # What are we doing?

As part of our works ahead of the construction of the railway, we will be continuing our winter programme of planting in the area. We will also be carrying out landscape maintenance. These works are due to take place from the 14 February 2022 for two weeks.

All trees will be dug and positioned by hand and undertaken by our arboricultural team.

There will be a maximum of three members on site working from a welfare vehicle.

The sites for the tree planting and maintenance works are located on the B4525, Byfield Road, A361 and Welsh Road.

# How this might affect you?

We will be working hard to ensure any impacts on residents are kept to a minimum during these works.

You may notice some extra traffic on the road immediately around the sites with workers moving to and from site.
