



Notice of works in Fradley and Streethay

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be undertaking works next to the South Staffordshire railway line near Streethay (see map on page 2). Our construction activities will include transporting materials to create a working platform and piling work, which is the process of installing foundations for future structures. To install the piles, we will drill a vertical hole deep into the ground and lower reinforced steel into the hole using a crane, before filling the hole with concrete and finally capping them with a beam.

To complete these works safely we will have controlled crossing giving priority for users of Public Right of Way Fradley and Streethay 6. Where our haul roads cross highways, bridleways and public footpaths, controlled crossings are put in place to ensure public safety.

Our working hours will be between 8am and 6pm Monday to Friday and when required 8am until 1pm on Saturdays. Our workforce can be on site one hour before and after to set up and secure our equipment.

Access to properties will always be maintained.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

Maintain access to Public Right of Way and local properties.

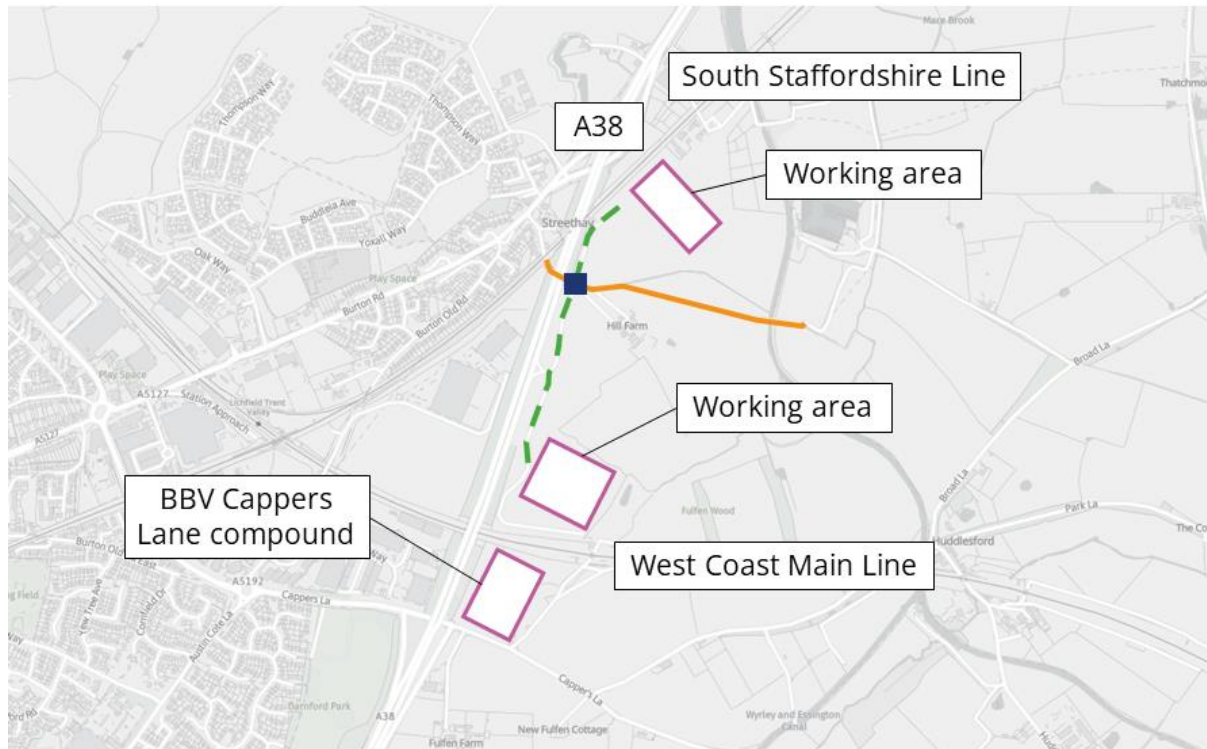

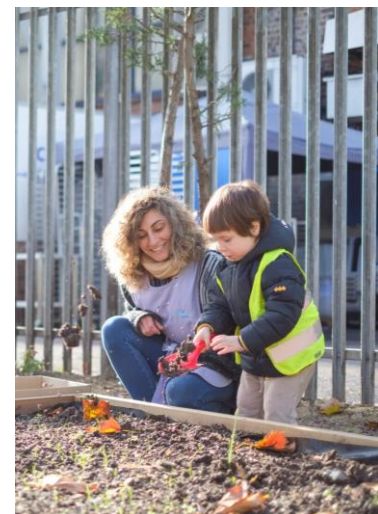
About our Community and Business Funds
