



# Notice of works Sutton Road, Drayton Bassett

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

We will be constructing accesses and satellite compounds across the HS2 route, in Drayton Bassett, to create a working area to commence the construction of the HS2 line, starting in late January. The first activity we will undertake is to create construction access roads and set up satellite compounds in our working areas.

The following works will be undertaken and will continue through 2022. We will:

- Continue site surveys across the working area.
- Receive deliveries of stone and materials to create the working areas
- Create construction access roads which will require works to develop bellmouth accesses off the local highway. These are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site. Access roads are Balfour Beatty VINCI's preferred logistical transport link, as they reduce the number of vehicle movements interfering with the existing local road network and provide the greatest possible control over works activity.
- Set up satellite compounds within our working areas to provide office and welfare facilities for our staff.
- Where construction access roads cross highways, bridleways and public footpaths, controlled crossings will be put in place to ensure public safety.
- Install drainage, undertake ground investigation surveys, and divert any utilities which are located, within our working area.

## When these works will take place

These works will take place from late January and continue through 2022. Access to properties will be maintained during these works.

These works will take place from late January and through 2022.

Our working hours will be 8am to 6pm weekdays and 9am to 1pm on Saturday.

Our workforce will be on site 1 hour before and after to set up and take down our work equipment.

Delivery of equipment, machinery and portacabins.

Essential surveys and utility works in and around our working area.
