

# Notice of overnight works next to railway tracks

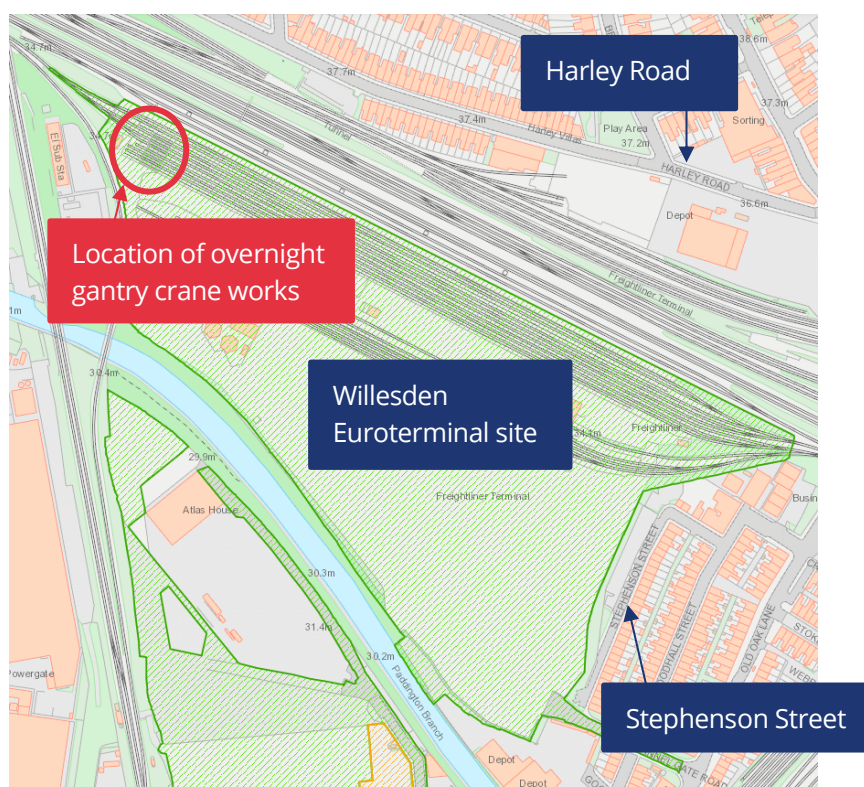

High Speed Two (HS2) is the new high speed railway for Britain.

## Overnight works on 6 March 2022

We will be carrying out overnight works on Sunday 6 March from 10pm to 7am the following morning. The works are needed to remove a cable hanging from the gantry crane in the Willesden Euroterminal site. These works must be carried out during an overnight railway track possession while trains are not using the tracks.

Our operatives will use mobile elevating working platforms and handheld power tools to carry out these works to minimise disruption to our neighbours. Task lighting will be used to carry out the works safely. A map showing the location of the works is included below.
