Periodic short term evening road closures

To enable the crossing of heavy or abnormal loads between the HS2 compounds on either side of A412 North Orbital Road, near Denham Water Ski Club, and between Moorhall Road North and South compounds in Hillingdon, short road closures will be required on occasion during the evenings from February 2022 to late July 2022.

These plant crossings are infrequently required, but when they are they will be scheduled for late evenings between 10pm and 1am to minimise disruption. When a temporary closure is put in place there may be 15 minutes intervals when traffic will be held in both directions at either of these junctions with our haul road. We appreciate that this is frustrating for anyone waiting at the traffic signals, however, these closures are to facilitate the safe crossing of heavy machinery,

Residential access to properties either side of the traffic lights on both the A412 and Moorhall Road will not be affected but may be subject to delay when plant is crossing. Please see map below for location of

What to expect

Delays to journeys on A412 North Orbital Road and Moorhall Road periodically for 15 minutes intervals between the dates and times above

What we will do

We will safely hold traffic at signals whilst heavy plant or abnormally long vehicles cross the road junctions with the haul roads on the A412 and Moorhall Road

Maintain residential and business access during the closure. Residents wishing to travel through the traffic lights will be held at the signals during the short-term closures.
