High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working on behalf of HS2 Ltd to build the new highspeed railway in your area.

What work will we be completing

To prepare for the construction of a railway bridge over the A45 it is necessary for us to replace the existing safety barriers and streetlights and install temporary safety barriers along the slip roads connecting the A45 and East Way. To complete these works in a safe environment, we will be implementing a full road closure of the slip road. A Fully signed diversion will be in place during these works (please see map).

When will the work take place?

The works will take place over a four-day period starting from **Monday** 14 March until Thursday 17 March 2022.


