## What we are doing

Over the coming months we will be carrying out works at Ruislip Golf Course, in the areas shown on the map overleaf. These works will help us to prepare the area for the redevelopment of the Golf Course.

Our works will include:

- Setting up security fencing and hoarding
- Utility investigations and surveys
- Archaeology works
- Ecological mitigation works
- U44 footpath diversion

During these works, public access points to the Golf course will be marked along the area and notice boards will be installed to keep the public informed.

We will continue to monitor noise, dust and vibration throughout our works to ensure that we have adequate measures in place to minimise disruption.

## Upcoming works

Duration	Activity	Description
7 March 2022 to 24 June 2022	Setting up security fencing and hoarding	Installing fencing along the area, shown in the map below (which will include strimming locally). Access to the golf course for the public will be maintained as long as possible by leaving access through the fencing.
7 March 2022 to 22 April 2022	Utility investigations and surveys	Ground penetration radar to scan and identify utilities. Excavation of trial holes to take measurements of the various assets in the area.
15 March 2022 to 21 December 2022	Archaeology works	Excavation of trenches, site mobilisation and compound set up with fencing, hard standings, and welfare accommodation.
6 June 2022 to 30 June 2023	Ecological mitigation works	Fencing installation, haul road construction, vegetation clearance and dewatering works leading to excavation and planting.
6 June 2022 to 30 June 2023	U44 footpath	Preparation works to secure and divert a section of the U44 footpath around the works area.
