



## Notice of road closure, Boddington Road

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. ### What are we doing?

As part of the preparatory works for our internal haul road we will close Boddington Road for approximately two weeks. These works were recently postponed and we now have confirmation of a new start date.

In order to avoid using local roads, during the main construction works, we will be using the internal haul and access roads for our construction traffic. As the project progresses, it is also necessary to remove vegetation to enable future works to continue and to allow access to areas of the site. We will create a strengthened surface using concrete to ensure that we protect the road and any utilities underneath it for the duration of our works.

Our plant crossing areas will be controlled with barriers and traffic lights. These traffic lights will only be activated during our operating hours and will ensure safe, controlled crossing from our works sites across the highway.

As the preparatory works will require large plant and machinery and time for concrete to set, we are required to fully close these sections of road, 24 hours per day, until they are complete. This is for the safety of road users and our staff.

### When will these works take place?

Boddington Road will be fully closed, 24 hours a day, from Monday 28 March 2022 to Monday 11 April 2022, with a diversion in place. We will work to open the roads to reduce disruption as soon as possible.

### Duration of works

Works will commence Monday 28 March 2022 and last for approximately two weeks.

24-7 full road closure.

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

### What to expect

Varied activities with both quiet and busier periods.

Road closures and some additional traffic.

24-7 closure will be required to allow concrete to set.

Noise from plant and equipment used for the works.

### What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

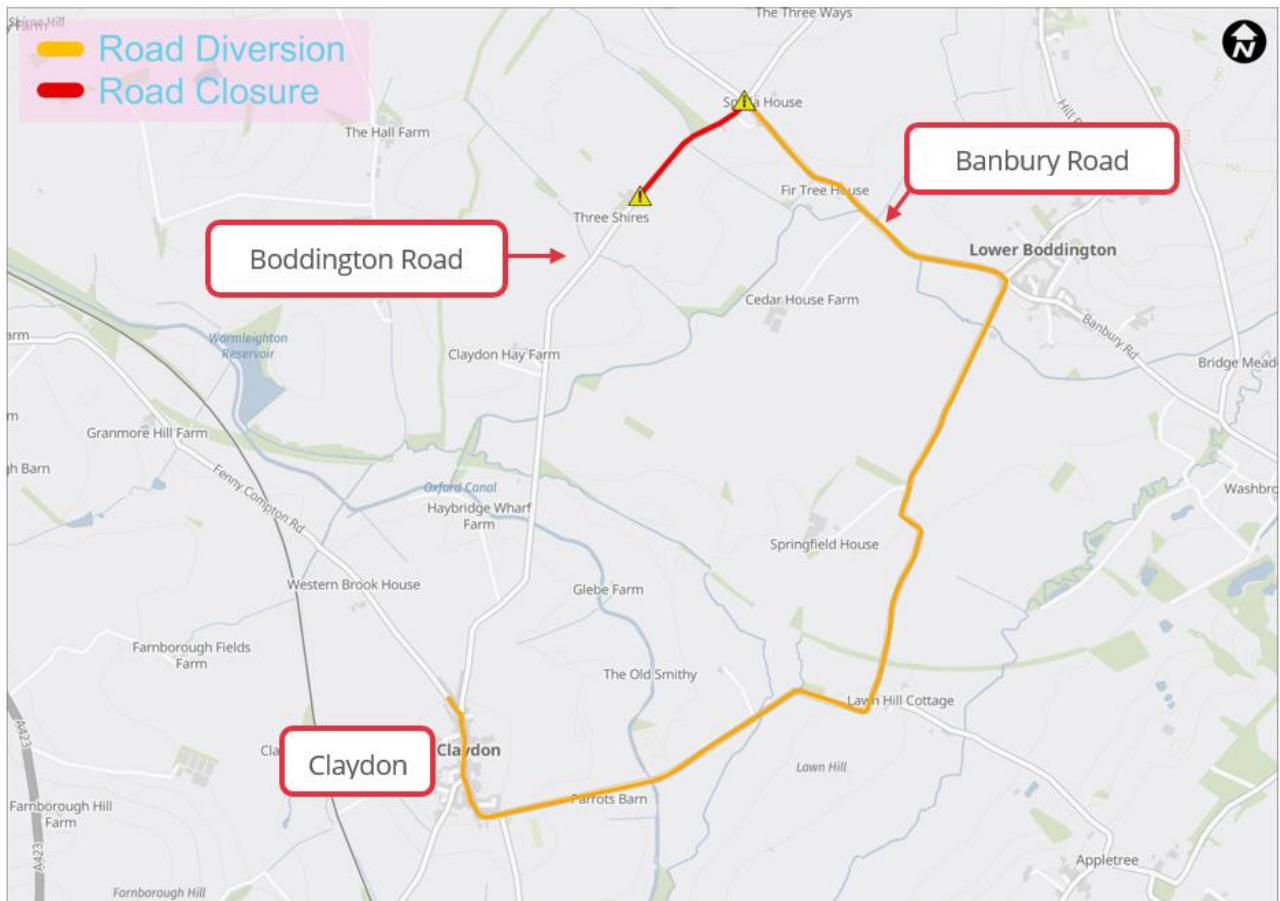
