High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

In order for us to create an entrance to our compound on Crackley Lane, Kenilworth, we will have a closure in place.

From Monday 28 February 2022 to Friday 4 March 2022, 24-hour temporary traffic lights will be in place, maintaining a route through Crackley Lane.

From Monday 7 March to Friday 11 March, a full closure will be in place with a fully signposted diversion route.

Please note that access will be maintained to frontages and businesses on Crackley Lane, Kenilworth while these works take place.

HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

Duration of works

Crackley Lane - temporary traffic lights will be in place from 28 February 2022 to 4 March 2022.

A full closure and diversion route will be in place from Monday 7 March to Friday 11 March.

Our workforce may be on site one hour before and after to set up and take down our work equipment.
