Notice of utility works on Curzon Street

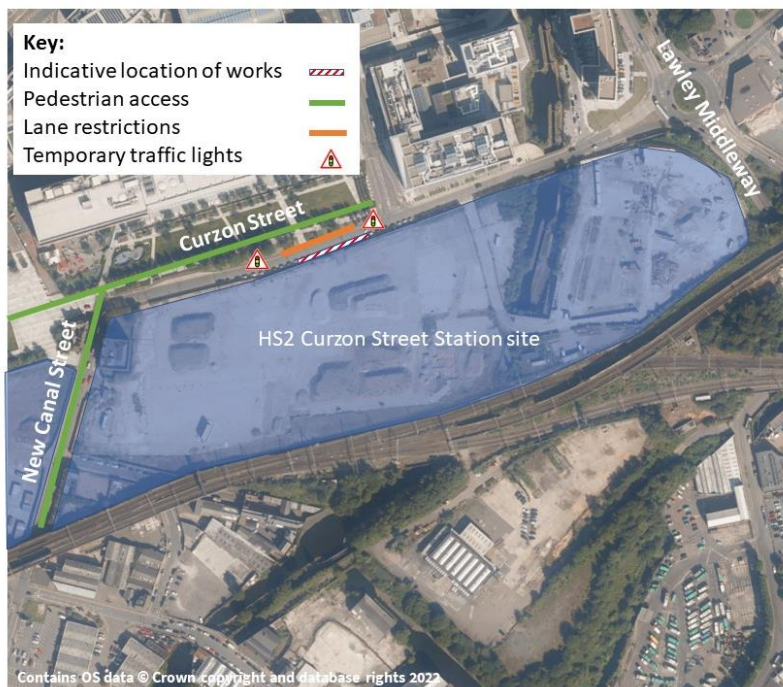

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

We will be carrying out utility works on Curzon Street.

As we continue works in preparation for the construction of HS2's Curzon Street Station and the railway, we'll be carrying out utility works on Curzon Street.

Whilst we carry out these works, we will need to manage traffic and pedestrian access. Pedestrians should use the walking routes along Curzon Street which will be clearly signposted. For vehicles, travelling along Curzon Street there will be a single lane closure, which will be managed by temporary traffic lights.
