High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons. Please note that the times and dates in this notification are subject to change.

We are working off Attleboro Lane

In order to prepare for the future construction of the railway, we will be carrying out vegetation removal in an area off Attleboro Lane. We'll be carrying out this work on weekdays from Monday 14th March until Friday 25th March between 8:00am and 6:00pm.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
