What we are doing

Ahead of the start of tunnelling later this year, we have been carrying out ground movement assessments to understand the possible impacts of tunnelling. At this location, we need to inspect and carry out minor protection works to the pedestrian footbridge that links to the Transport for London depot.

The trackside area shown on the map overleaf will need to be cleared of brambles and weeds.

About our Community and Business Funds
