High Speed Two (HS2) is the new high speed railway for Britain. High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys. For the safety of both our workforce and motorists, we need to close Dog Lane and Bent Lane and install temporary traffic lights on the A51 junction.

When the work will take place

This will take place from **Monday 28 February to Friday 25 March 2022**. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.

For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. How this will affect your journey

On **Monday 28 February to Thursday 3 March** from **9am to 4pm** we need to close Bent Lane. We will put a signed diversion route in place for motorists to use, and please allow an additional 10 minutes for your journey time. We will maintain access to all properties within the traffic management set up.

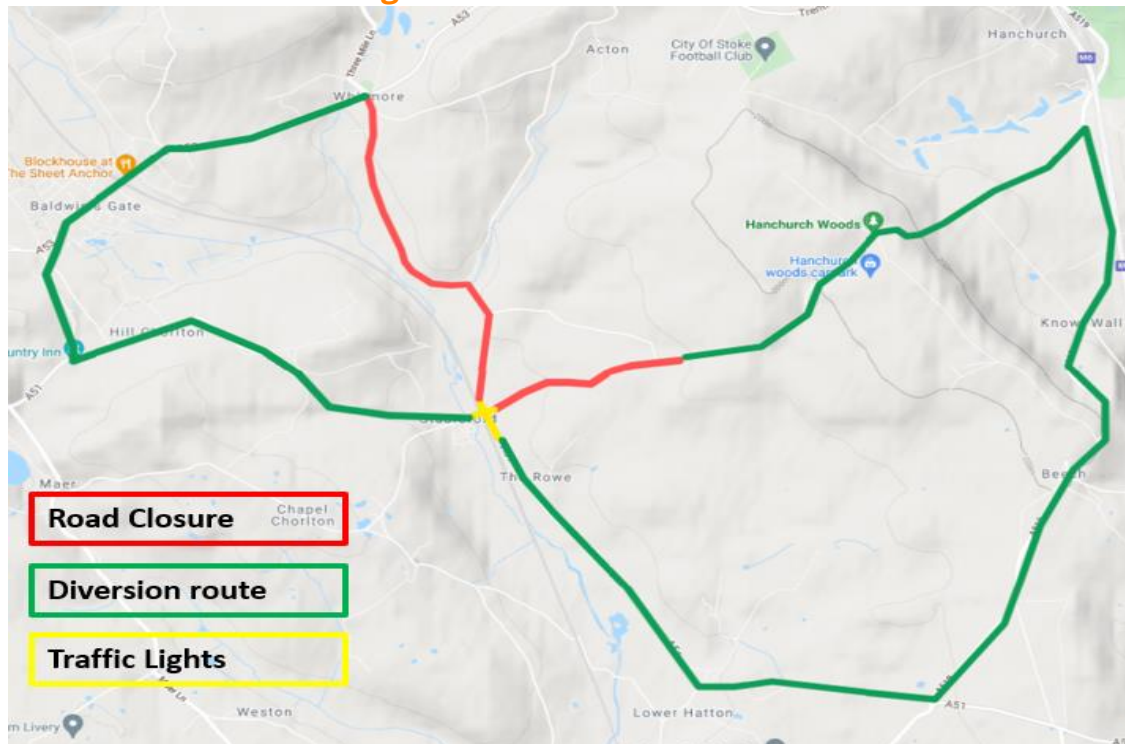
On **Wednesday 2 March to Friday 11 March** from **9am to 4pm** we need to close Dog Lane. We will put a signed diversion route in place for motorists to use, and please allow an additional 15 minutes for your journey time. We will maintain access to all properties within the traffic management set up.

On **Monday 7 March to Friday 25 March** from **9am to 4pm** we need to install temporary traffic lights on the A51 junction leading off Bent Lane and Dog Lane. Please allow additional time for your journey during this time.

How we will minimise disruption

To limit disruption, we will only carry out one activity at a time and the nature of the work is non-intrusive and should not affect nearby properties. We will maintain access to all properties within our road closure and provide fully signed diversion routes, with advance warning signs on display to notify motorists of the upcoming work.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
