## Notice of temporary road closure on Lichfield Road for pre survey work

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

### What we are doing

We will be carrying out pre survey work to help us undertake light detection and ranging (LIDAR) surveys. This pre surveys work is non-intrusive and involves putting targets on the road and footpaths.

On a different day a helicopter will be in the area to accurately measure distances between the targets. This will allow for a 3D model of the terrain to be created.

### When the work will take place

The temporary closure will take place on Lichfield Road between **9am and 4pm Saturday 12 February 2022** and last around 15 minutes. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances. We will notify you in advance of any changes.

### Covid-19

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff.
