High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route

# What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys along the Tixall Road, Mill Lane and Hoomill lane

# When the work will take place

Work will take place from **Monday 21 February** to **Friday 4 March 2022.** Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances. We will notify you in advance of any changes.

# How this will affect your journey

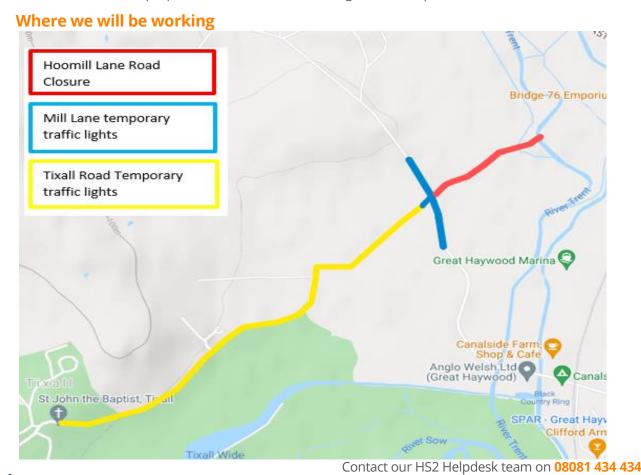
On **Monday 21 February** to **Thursday 24 February** from **9pm** to **6am** we need to install temporary traffic lights on Mill lane and the junction of Tixall Road. This work is a quiet activity, and the location will differ on each day as we move along the carriageway. Please allow additional time for your journey during this time.

On **Friday 25 February** from **9am** to **5pm** we need to close Hoomill Lane. No diversion route will be required, and we will maintain access to all properties within the traffic management set up.

On **Thursday 24** to **Friday 4 March (excluding weekends)** from **9am** to **5pm**, we need to install temporary traffic lights on Tixall Road. The location will differ on each day, day as we move along the carriageway. Please allow additional time for your journey during this time.

## How we will minimise disruption

To minimise disruption, we will be undertaking the work using overnight temporary traffic lights where possible. The nature of the work is non-intrusive and should not affect nearby properties. We will maintain access to all properties within the traffic management set up.

# **About our Community and Business Funds**

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
