

Notice of survey work on Pipewood Lane and Luth Burn

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys. For the safety of both our workforce and motorists, we need to close Pipe Lane and Luth Burn overnight.

When the work will take place

This will take place from **Friday 4 March** to **Tuesday 22 March 2022**. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.

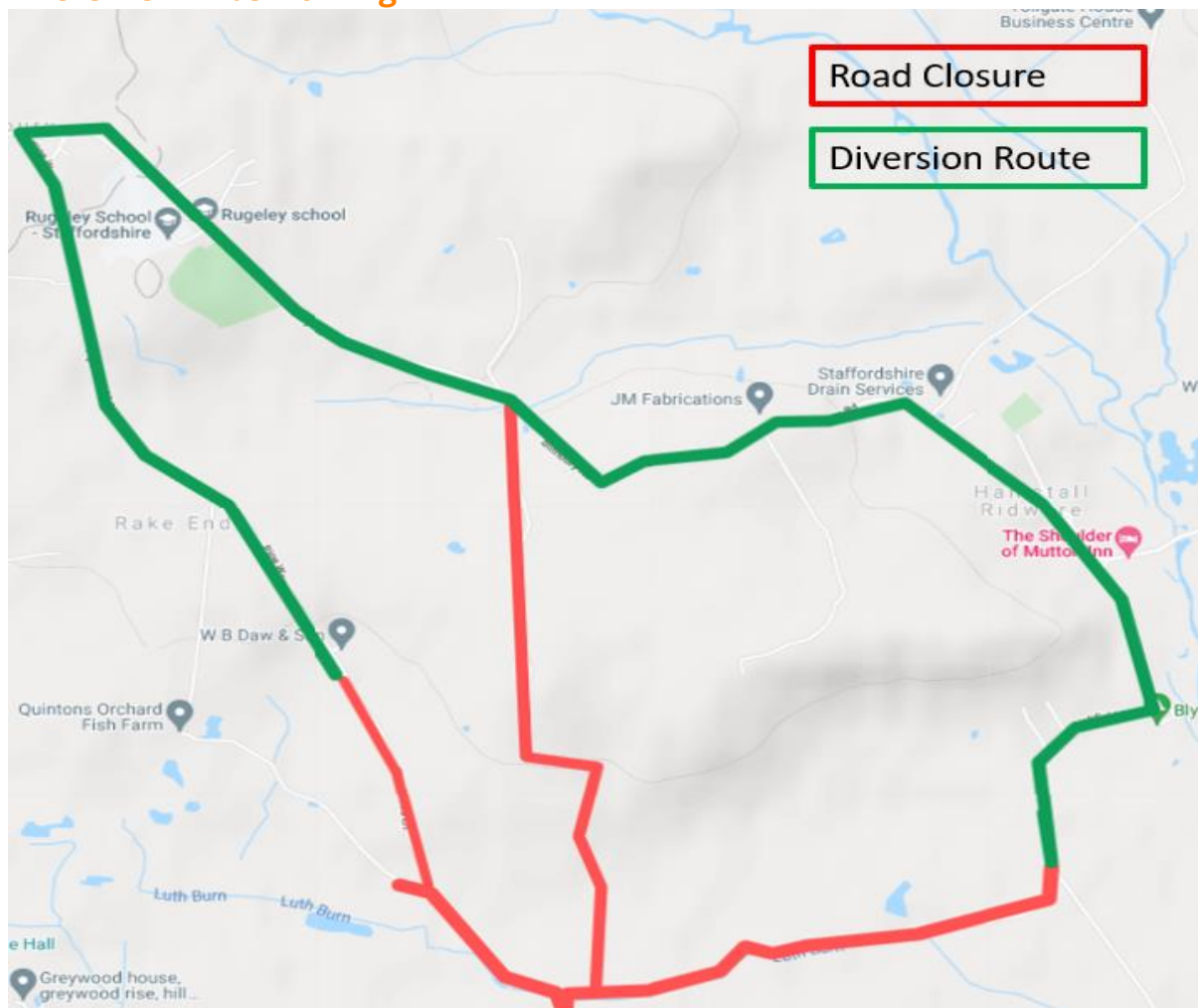
How this will affect your journey

On **Friday 4 March** to **Thursday 22 March** from **8pm** to **6am** we need to close Pipewood Lane and Luth Burn. We will put a signed diversion route in place for motorists to use, with advance warning signs on display to notify motorists of the upcoming work. please allow an additional 15 minutes for your journey time.

How we will minimise disruption

To limit disruption, we will only carry out this activity overnight and will maintain access to all properties within our road closure. In addition to our operatives manning the closure to allow access, we will install several interacting talk boards installed for instant communications with resident and business and our workforce to arrange access. The nature of the work is non-intrusive and should not affect nearby properties

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
