



# Notice of compound near Attleboro Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

From Monday 14 February BBV will begin to construct a compound in an area to the west of Attleboro Lane for our construction team to work in. The construction of the compound will initially be earthworks including the excavation, backfilling and compaction of materials. Following this, concreting, tarmacking and lifting activities will take place. Once the compound is constructed in March, it will be used for the duration of the project.

The compound will consist of two single story buildings, with one of the buildings as an office and the other for welfare facilities. The office will occupy up to 50 members of staff and the welfare facilities has a capacity of 125. BBV will erect a hoarding on the east side of the compound to reduce the visibility of the site. The compound will have a car park and access will be from the B4118 Birmingham Road via our internal haul road.

## HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

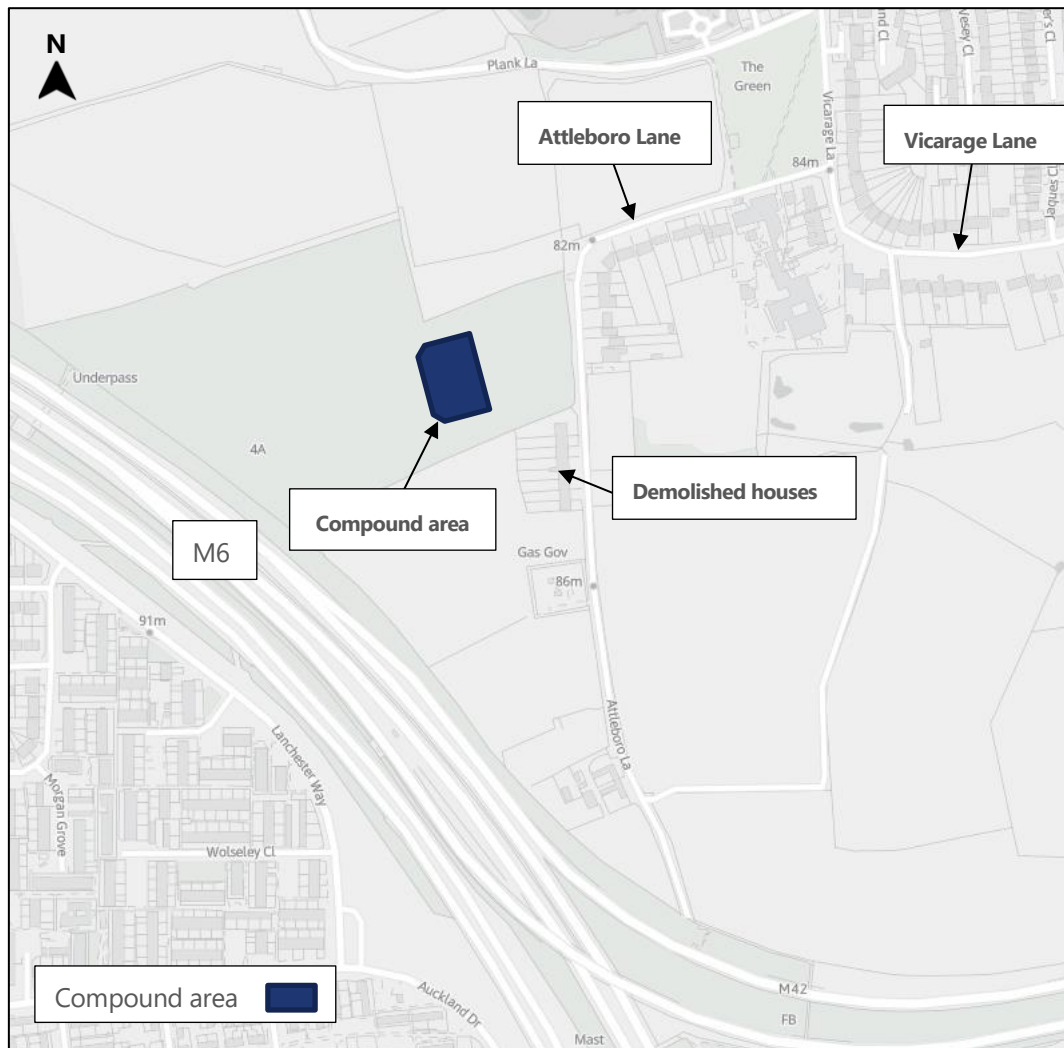

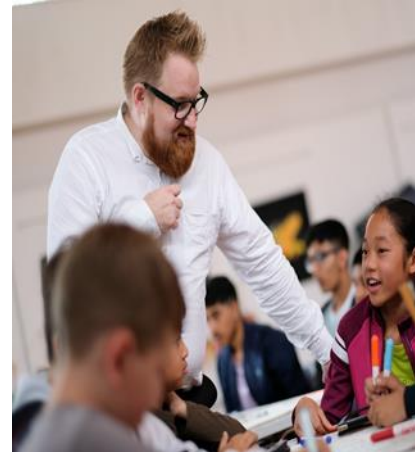
## About our Community and Business Funds
