High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. Essential Repair Work

There will be some weekend works taking place from 19 February, for approx. 3 weeks, on both Saturday and Sundays, to carry out essential repairs to one of the piling rigs on site. We anticipate these works to complete on Sunday 6 March.

The works will consist of hammering and a few light vehicles such as forklift to move tracks.

The team will install acoustic barriers in front of the works on the side facing residents and the works will take place close to the concrete batching plant and will not be directly in front of residents' homes.

The hours of work will be as per agreed times for exceptional plant repair:

- Saturday between 13:00 and 18:00
- Sunday between 10:00 and 17:00

Duration of works

From 19 February for approx. 3 weeks on Saturday between 8am and 6pm and Sundays between 10am and 5pm. We anticipate these works to complete on Sunday 6 March.

What to expect

The works will consist of hammering and a few light vehicles such as forklift to move tracks.

What we will do

We will use best practical means to minimise disruption to residents and install acoustic barriers in front of the works.


