



# Notification of temporary hard shoulder closures on the M42, near Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## We're preparing to build the railway

Subject to obtaining the relevant consents, we will be removing vegetation along the M42 carriageway in March to prepare for the future construction of the HS2 railway.

## We'll be starting work on Monday 7 March

To carry out this work safely, we'll install temporary hard shoulder closures along short sections of the M42 northbound and southbound from **Monday 7 March to Friday 18 March** (see map on page 2). Our working hours will be 9.30am to 3.30pm, Monday to Friday.

Our contractors may be on site up to an hour before and after those times to set up and close down the site.

## HS2 during the coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current strategy makes clear that construction activity can continue if it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

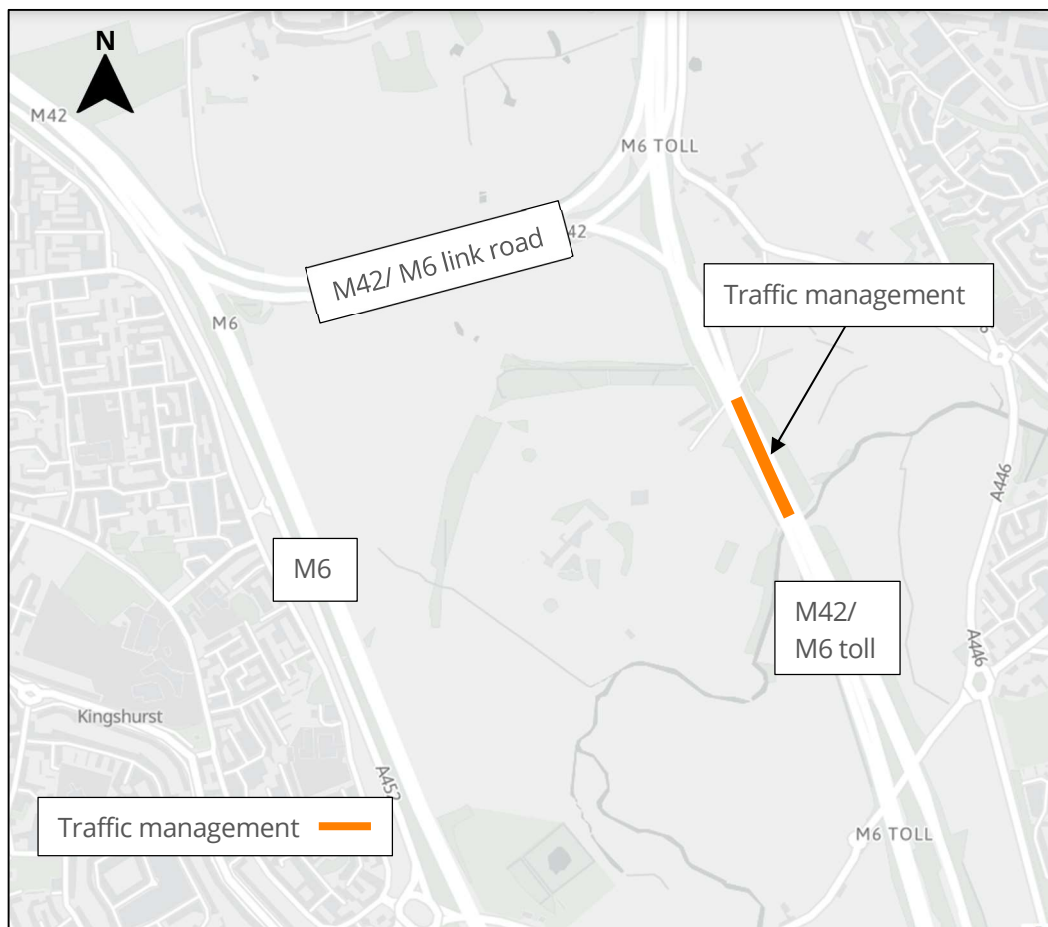

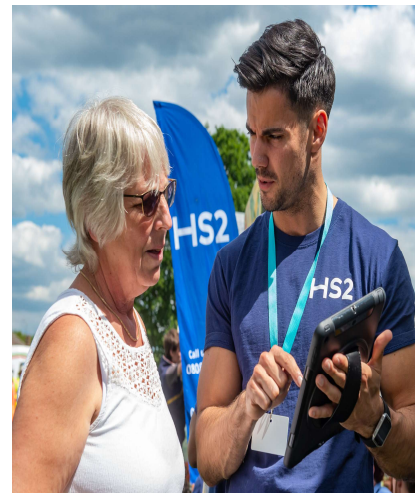
## About our Community and Business Funds
