



# **Road Closure - Frith Hill** South Heath Leg

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. The health and safety of our workforce and the communities we work within is our priority. If you have any questions about this, please contact our Helpdesk to find out more.

### What are we doing?

Affinity Water will be disconnecting the previous water supply that fed Weights and Measures. We also require a connection to the water main to cater for our offices at the North Portal which we have arranged to happen altogether under one closure. To do this, the road will be excavated making it unsafe to leave open to traffic. Fencing will be visible.

### How will this affect you?

Frith Hill South Heath Leg will be closed to traffic in both directions from 6am on 21 February - 6pm on 23 February.

Diversion route signage will be in place. See map on page 2.

### What about pedestrians?

The footpath will remain open to pedestrians as the excavation will be safely fenced off.

### Has this closure been approved?

Yes. Affinity Water have obtained their own consent from the local consenting authority, Buckinghamshire Council, to carry out these works. A permit has been granted.
