What we are doing

We wrote to you on 7 February to advise you we would be carrying out clearance works in the area below. These works will now take place from 28 February to 4 March. In preparation for the start of tunnelling later this year, we need to protect the sewer in this location. We need to set up a works compound on the Network Rail land (as shown on the map) from which we can carry out the sewer protection works. However, before we do that, we will need to clear the hedgerow on the allotment access road and clear areas of vegetation and reeds as marked on the map below.

Use of strimmers, hedge trimmer, chainsaw and a wood chipper

What we will do Heras fencing with noise reducing blankets

Netting on fencing to catch any debris
