High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

Upcoming drainage inspections

We will be carrying out a series of drainage surveys in locations on or near to the Aston Church Road Roundabout on the A47 Heartlands Parkway. These will take place from Monday 7 March to Thursday 10 March. Dates are subject to the progress of the surveys programme.

These surveys will help us to plan where utility diversions will be required as we prepare to construct the railway in Birmingham.

Drainage inspections are non-intrusive surveys, which means that the inspection will only consider that which is visible and accessible. An operative will lift the manhole cover, use a sewer camera to examine the underground pipes and then replace the cover.

Lane closures

To be able to carry out these inspections safely and effectively, we will need to put in place overnight lane closures on a section of A47 Heartlands Parkway, along with inner lane closures on Aston Church Road Roundabout. These will be in place on Monday 7 March to Thursday 10 March.

These closures will be in place from 10.00pm to 5.00am. Access to properties and businesses will be maintained at all times.

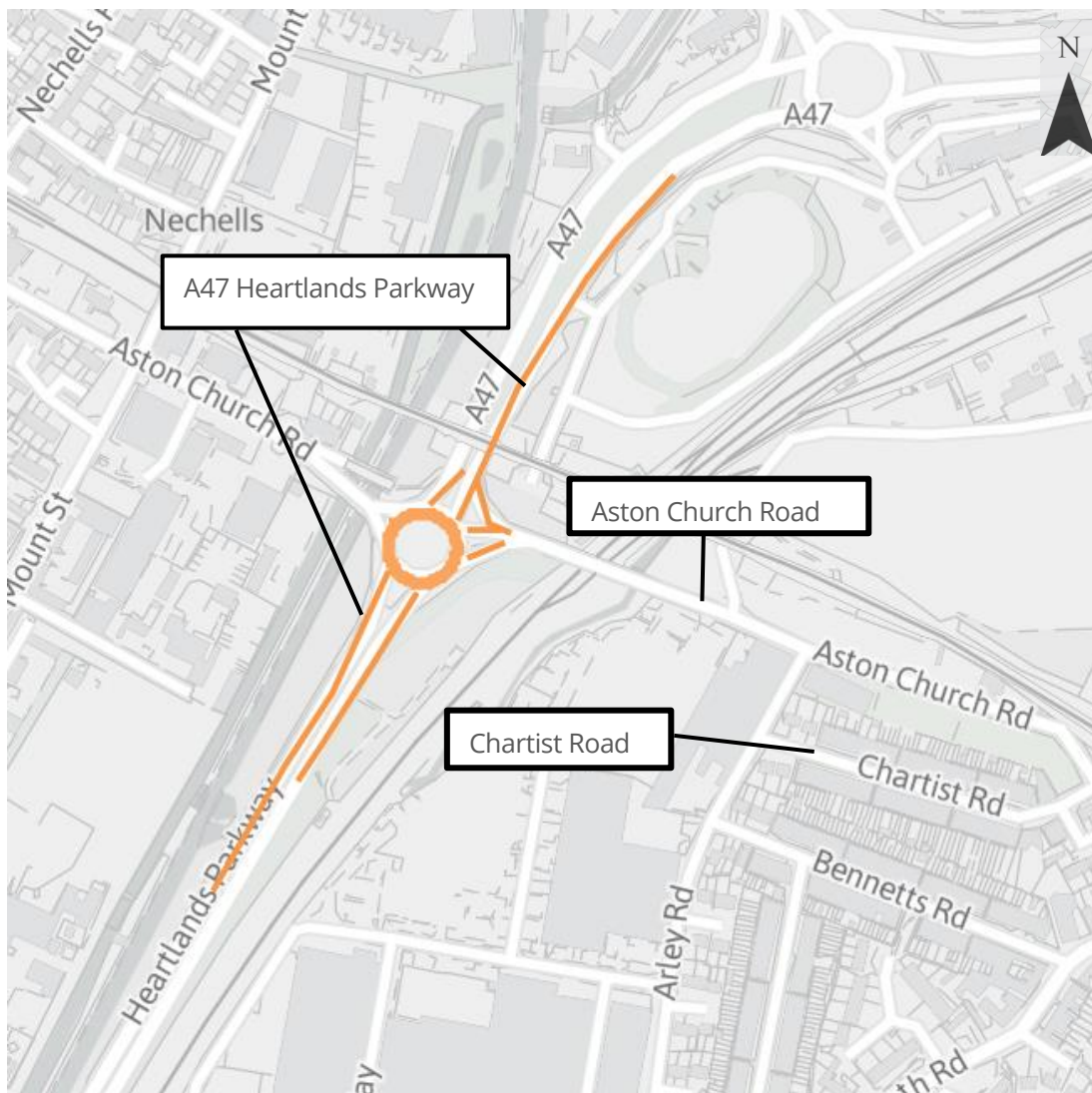
