



Updated notification: Traffic management Wood End Lane, Fradley

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we are doing

We will be installing temporary traffic lights and a lane closure on Wood End Lane, this is to allow us to safely carry out utility surveys in this area, including, CCTV drain clearance, Ground Penetration Radar Survey (GPRS) and trial trenching, which will involve digging into the ground to establish what utilities are underneath the surface. This will provide us with information we need to develop our construction plans.

When will these works take place

Due to adverse weather conditions we need to extend our working at Location 2 by two weeks, and will complete our current activities by Friday 11 March.

The location of these works are shown on a map overleaf. Our working hours will be from 8am until 6pm Monday to Friday. Our workforce can be on site one hour before and after, to set up and secure our equipment. Access to properties will always be maintained.

Other works included within this notification are now complete:

- Location 1: From 29 November 2021 until 17 December 2021
- Location 2: From 17 January 2022 until 28 January 2022
- Location 3: From 31 January 2022 until 4 February 2022

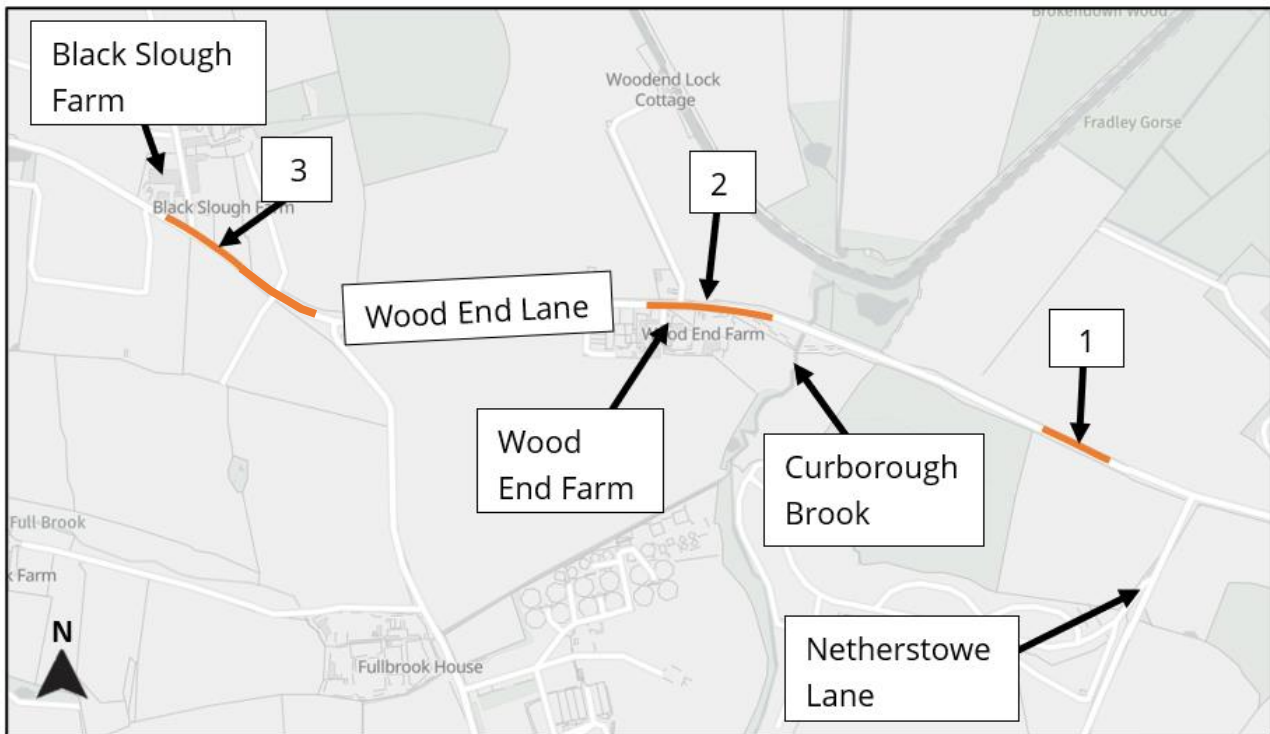
