The work we will be doing

As part of the HS2 works for Carol Green Bridge construction, Balfour Beatty Rail will be carrying out **new installation works** for the lowering of the overhead power lines of the West Coast Main Line - near to Berkswell Station where HS2 crosses via a new overbridge.

These works are due to take place from 1.40am on 16 April through to 5.00am on 19 April, during a full railway closure.

The West Coast Main Line will be closed and Network Rail will be providing a shuttle bus service from Berkswell Station as an alternative. Please visit the Network Rail web site to help you plan any journeys over this weekend. www.networkrail.co.uk/

The workforce will access the railway through the rear of Berkswell Station car park and Truggist Lane compound. We will keep you updated through www.hs2insolihull.co.uk.

 - Low level noise from the works.


