High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

#### The work we are doing

We will be installing temporary traffic lights and lane closures on Wood End Lane. This is to allow us to safely complete the construction of new junctions to connect our haul roads, minimising disruption where possible.

### When will these works take place

These works will take place in two locations along Wood End Lane, please see map overleaf.

- Location 1: From 28 February until 25 March
- Location 2: From 28 March until 22 April.

Our working hours will be from 8:00am until 6:00pm Monday to Friday. Access to properties will always be maintained. Our workforce can be on site one hour before and after to set up and secure our equipment.

Please be aware there are other contractors working within the area for three nights from 7 March until 10 March, carrying out survey work to investigate the location and condition of buried cables. You can check one.network for the latest information about traffic management in your area.

#### **HS2** and the COVID-19 outbreak

#### Temporary lane closures with traffic lights Wood End Lane.
