

Notice of works to install Ground Anchors at Adelaide Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at www.hs2.org.uk.

Installation of Ground Anchors

As part of our works to prepare for the construction of the ventilation shaft, we wrote to you in February 2022 about the installation of Ground Anchors on our Adelaide Road site.

Ground Anchors are lightweight, corrosive resistant rods or cables installed into the ground to hold, restrain, and support buildings, civil engineering works and other structures.

The installation of Ground Anchors on our Adelaide Road site will pass beneath the footway, road, and properties from the Network Rail embankment area; the northern side of Adelaide Road; the eastern side of the Nature Reserve.

These works are due to take place in May 2022. We anticipate that the Ground Anchors will be installed in three phases and will take up to 19 weeks to install.

Duration of works

From 2 May 2022 for the duration of 19 weeks

8am to 6pm, Monday to Friday and 8am to 1pm, Saturdays

We may be on site for an hour before the start and/or end of each shift

What to expect

Before we carry out our works to install the ground anchors, a series of external surveys will be undertaken to best understand the configuration and visual condition of the neighbouring properties

Access will not be required to the properties situated above the locations of the ground anchors

All works will be carried out within our site

What we will do

Advise our staff to be mindful of our neighbours

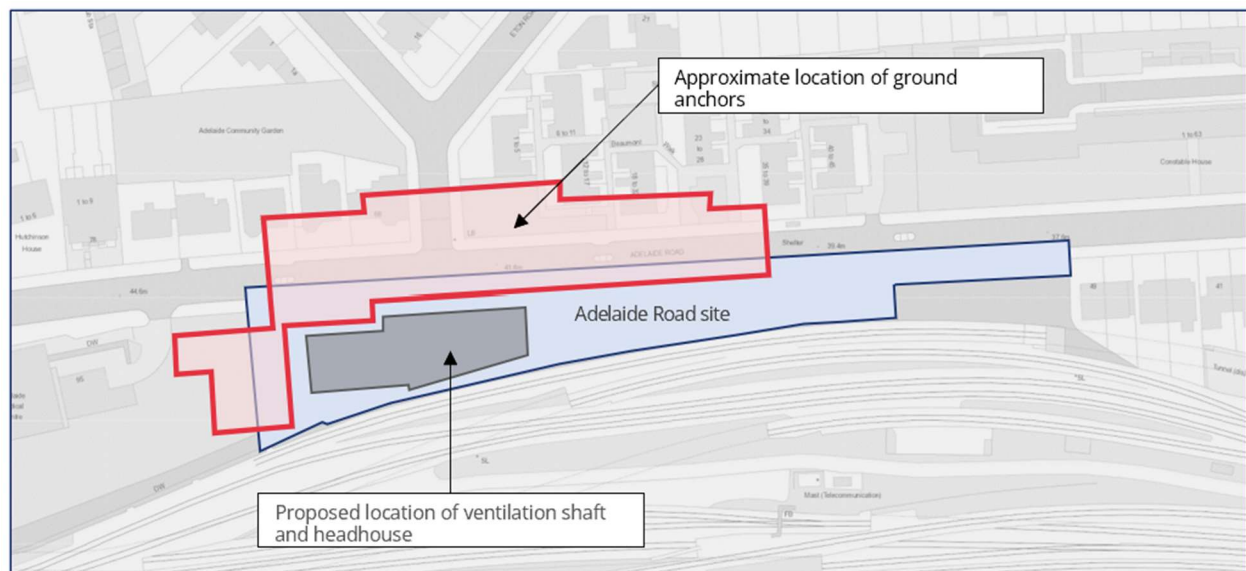

How will they be installed?

The ground anchors at our Adelaide Road site will pass beneath the footway, road, and properties from Network Rail embankment area to the northern side of Adelaide Road and eastern side of the Nature Reserve. We will drill a hole from track-side to pass through the retaining wall and beneath the street and properties. Then we will install a liner and steel reinforcement, followed by grout.

We will install 235 anchors which will be up to 35 metres long and one to three metres apart.

No additional traffic management will be required.



Upcoming works on Adelaide Road

From summer 2022, we will be carrying out additional utility works on Adelaide Road. These works are needed to ensure we protect utility services while we build HS2. These works include a proposed road closure at the junction of Adelaide Road with Eton Road.

As part of our ongoing commitment to keeping local residents informed, we will be carrying out further engagement about these works over the coming weeks. We will write to residents with further information shortly.
