High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be undertaking vegetation clearance in areas along the B4114 for works to create site accesses. For us to complete these works safely, we will implement a three-way traffic light system on the B4114 Birmingham Road. The traffic lights will be in place from Monday 21 March until Tuesday 29 March.

Our traffic lights will be in place 9.30am until 3.30pm Monday – Friday and 9.30am – 1.00pm on Saturday.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. - Three-way traffic lights in place on the B4114
- Works to be undertaken from 21 March until 29 March

- Vegetation clearance to be completed in areas along the B4114
- Slight increase to traffic on the B4114 Birmingham Road
- Our workforce may be on site 1 hour before and after to set up and take down equipment

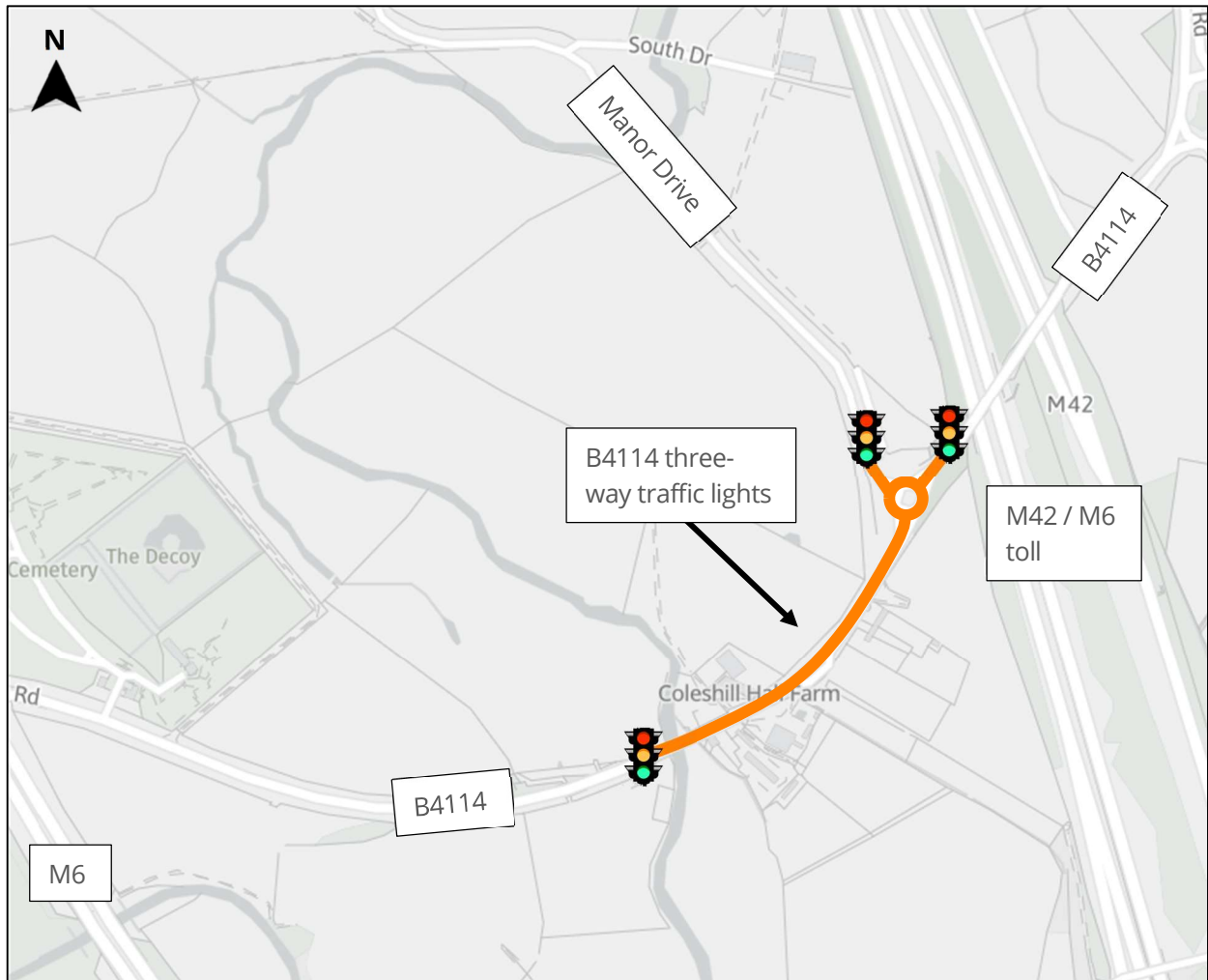
