



## Road closure, Ashow Road (B4115), Stoneleigh Road and Birmingham Road, Stoneleigh

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be completing

We will be undertaking survey works in preparation for the installation of traffic lights at the junction of Ashow Road (B4115), Stoneleigh Road and Birmingham Road in Stoneleigh. To complete this work safely we need to close the crossroads at this location. A fully signed diversion will be in place during this closure. (Please see map included). Access to properties will be maintained at all times.

### Duration of works

The road closures will be in place from **Monday 28 March to Friday 1 April** between the hours of **8am** and **6pm**. Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

### HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

- Keep all sites safe and secure

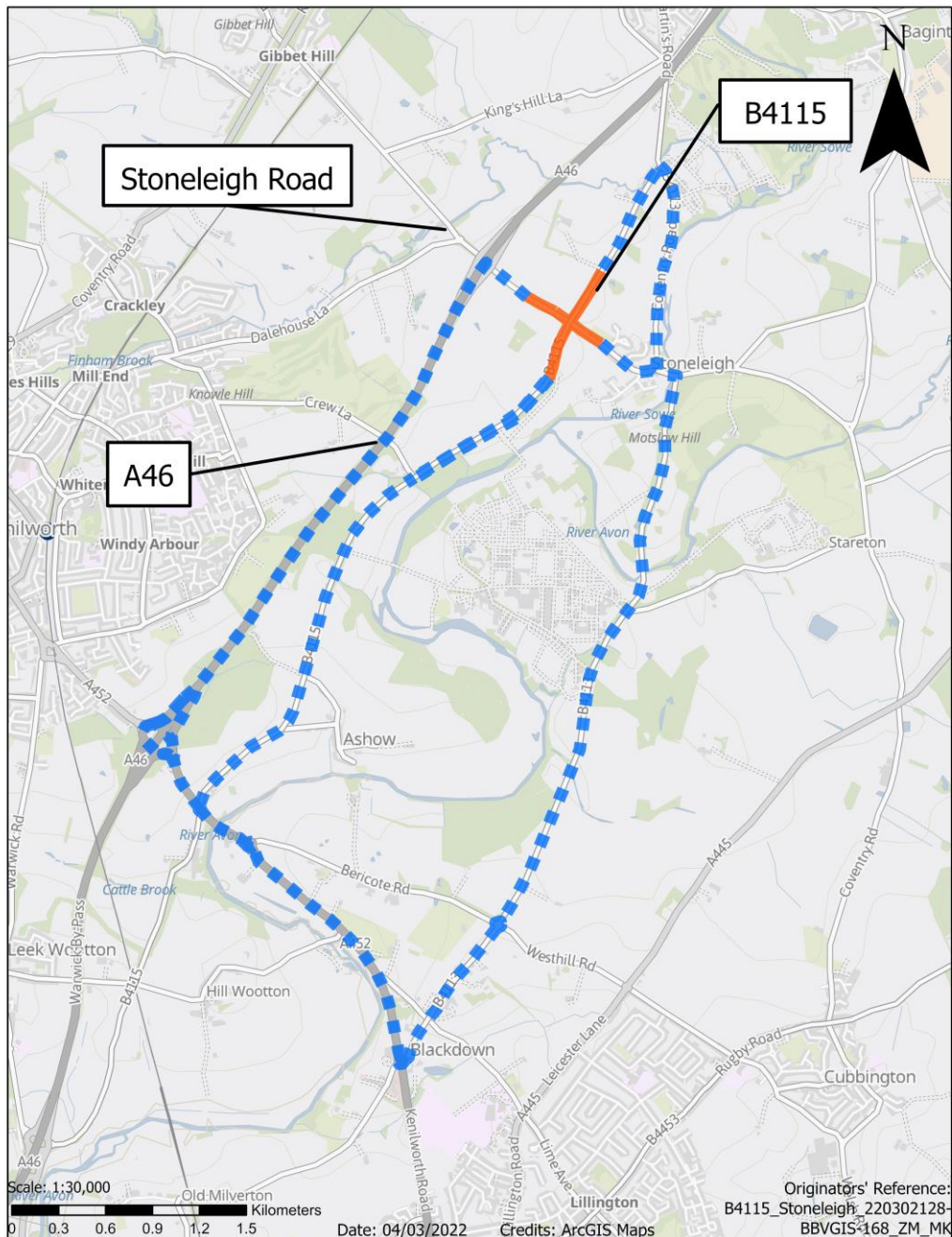
