



# Notice of road closure Cromwell Lane.

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## Traffic management update

In order to continue our works in the area including the demolition and removal of the existing substation safely, we need to close Cromwell Lane in two phases.

**Phase one**, will be a full closure between **Monday 11 April 2022** and **Friday 22 April 2022** 24 hours per day 7 days a week.

**Phase two**, will be an off-peak closure between **9.30am and 3pm** Monday to Friday and **8am to 1pm Saturdays** from **Monday 25 April 2022** to **Monday 13 June 2022**.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.

A fully signposted diversion route will be in place and access to properties will be maintained. We will reopen the road as soon as possible.

## HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority.

Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

## Duration of works

**Phase 1** Full closure between 11 April 2022 and 22 April 2022 24 hrs a day 7 days a week

**Phase 2** Off-peak closure in place from 25 April to 6 June 2022, between 9.30am and 3pm Monday to Friday and 8am to 1pm on Saturdays

Our workforce may be on-site one hour before and after setting up and securing our equipment.

Some limited disruption to travel times.

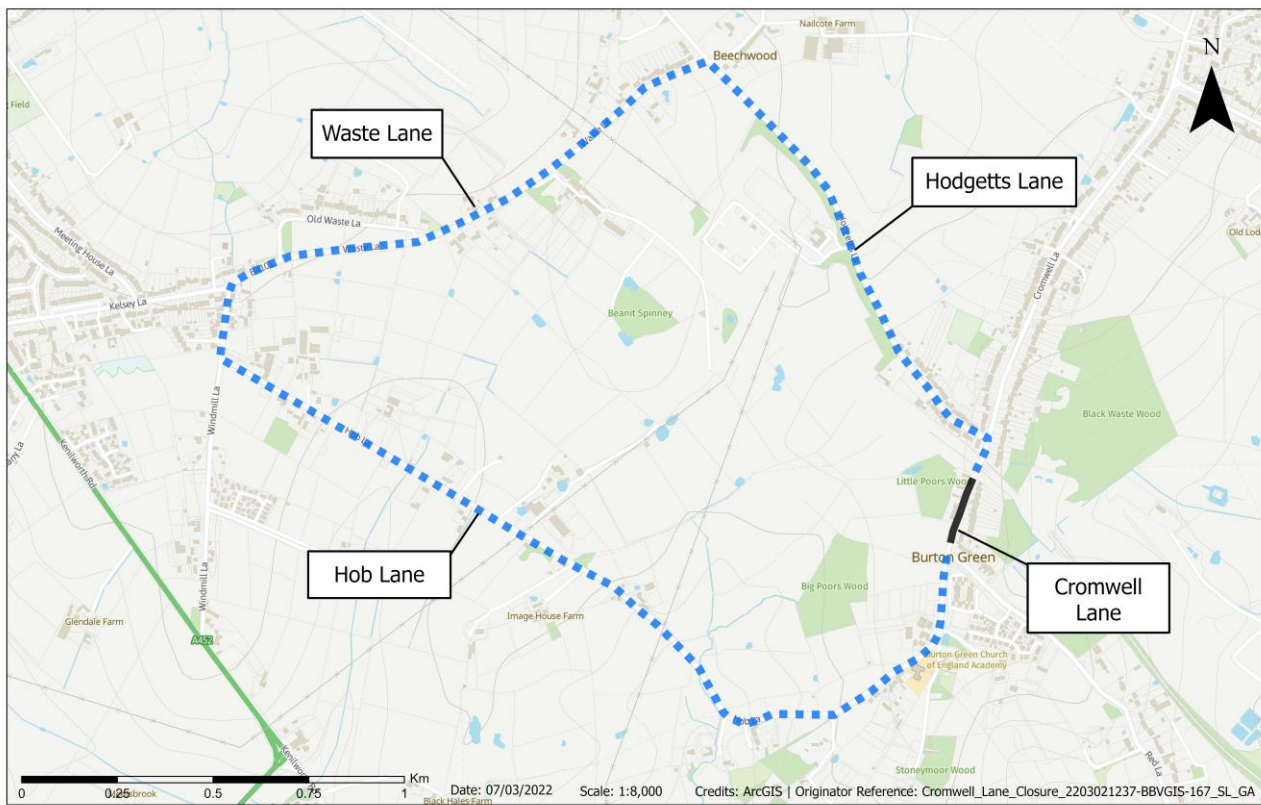
Fully signposted diversion route in place.
