High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

In March 2022, BBV begin works in areas to the north of Gilson Road. The works will initially include us setting up site and delivering machinery. Following this we will conduct ground investigation works, utility diversions and haul route construction works. The haul route works will involve excavating, topsoil stripping and the creation of internal haul roads.

We will access our works from Gilson Road, as identified on the map below. Our working hours will be 8.00am – 6.00pm Monday to Friday and 8.00am – 1.00pm on Saturday.

COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. 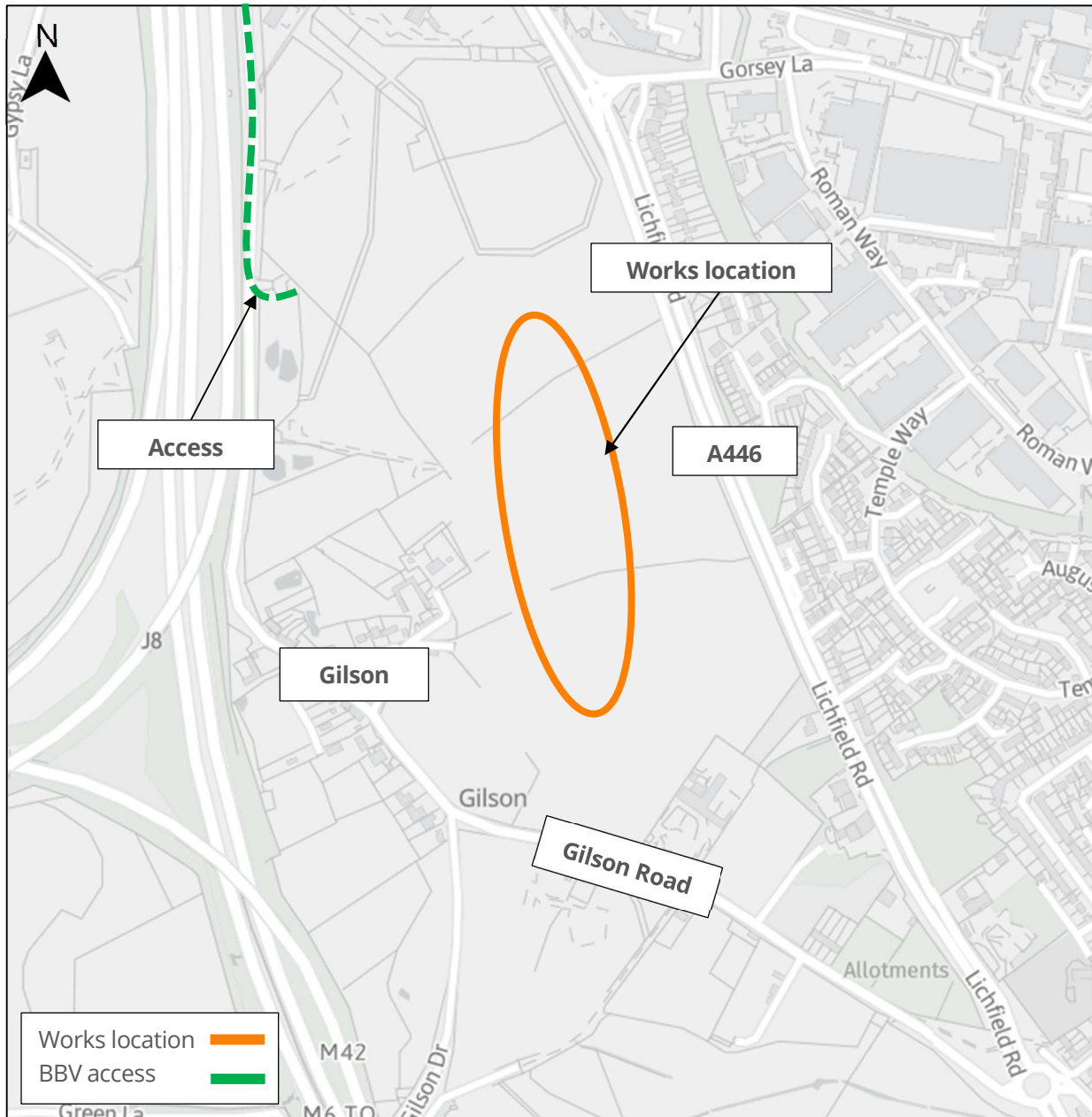
