



### Notice of survey work on the **A53 between Coneygreave Lane and Bent Lane**

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route

#### What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys. For the safety of both our workforce and motorists, we need to install overnight temporary traffic lights on the A53 between Coneygreave Lane and Bent Lane.

#### When the work will take place

This will take place from **Wednesday 9 March** to **Friday 11 March 2022**. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.

#### Covid-19

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. 
#### How this will affect your journey

On **Wednesday 9 March** to **Friday 11 March** from **9pm** to **5am** we need to install temporary traffic lights on the 53 between Coneygreave Lane and Bent Lane. The location of these will differ on each night. Please allow or a small delay when planning your journey.

#### How we will minimise disruption

To limit disruption, we are carrying out this work under temporary traffic lights overnight, avoiding the need of a road closure and only installing the traffic light on a small section at a time. Will maintain access to all properties within the traffic light set up. The nature of the work is non-intrusive and should not affect nearby properties

#### **About our Community and Business Funds**

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
