

# Notice of survey work on Tolldish Lane, the A51 and Main Road

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route

## What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys. To carry these out safely, we will need overnight road closures on Tolldish Lane, and traffic lights on the A51 and Main Road.

## When the work will take place

Work will take place from **Thursday 17 March to Friday 1 April 2022**. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances. We will notify you in advance of any changes.

## Covid-19

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. ## How this will affect your journey

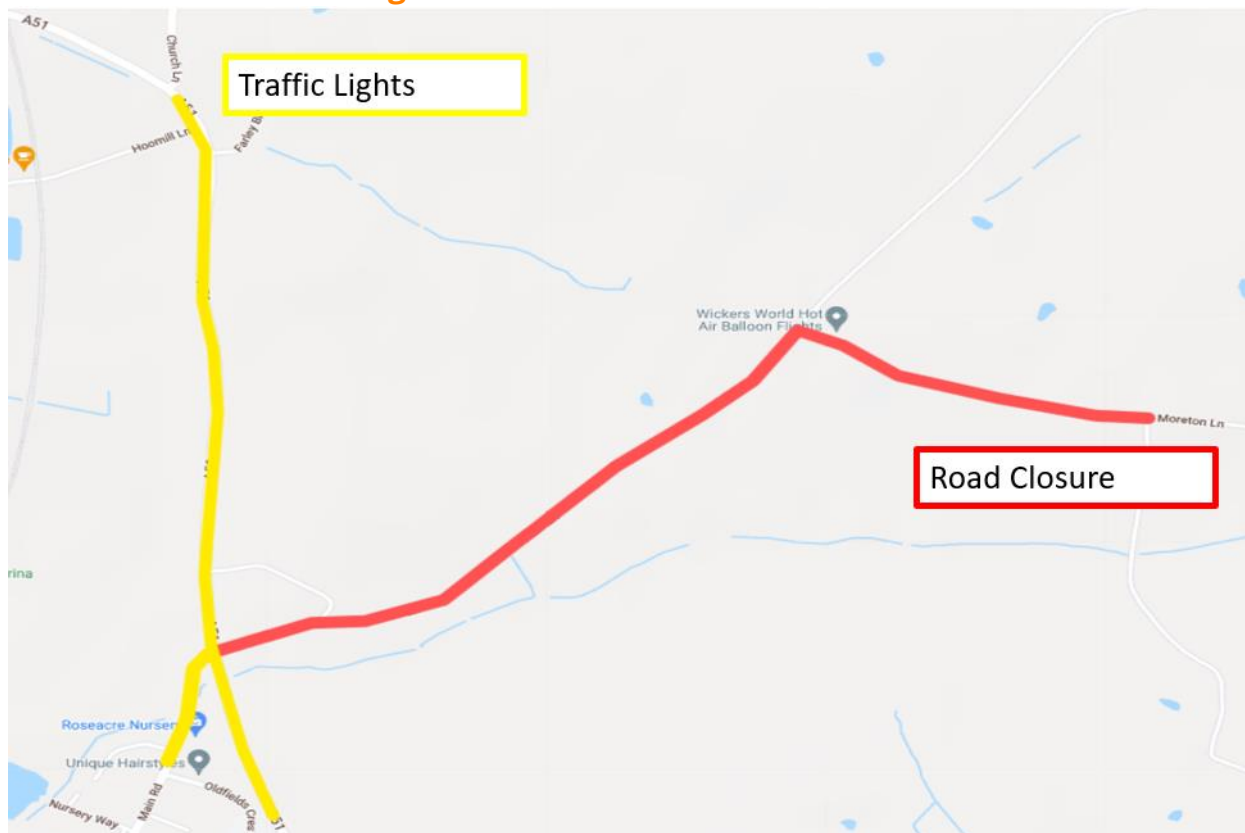
On **Thursday 17 March to Friday 1 April** (excluding weekends) from **8pm to 5am** we need to close a section of Tolldish Lane. There will be no diversion route in place, however, we will install several interactive talk boards for residents and businesses to instantly speak to our workforce to arrange access through the closure safely. To notify motorists in advance, warning signs will be installed.

During this time, we will also need to install temporary traffic lights on the A51 from the junction of Hoomill Lane till the south of Tolldish Lane, and a small section of Main Road. To notify motorists in advance, warning signs will be installed, however please allow additional time when planning your journey.

## How we will minimise disruption

To limit disruption, we will carry this work out overnight. We will also maintain access to all properties within the traffic management set up. The nature of the work is non-intrusive and should not affect nearby properties.
