

Notification of upcoming road closure A445 Leicester Lane, Cubbington

High Speed Two (HS2) is the high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be creating a plant crossing on A445 Leicester Lane, Cubbington. This crossing will allow us to safely move our construction plant across the road as we undertake various earthworks in the area. Once completed this crossing will allow the use of our haul road. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site. Haul roads are Balfour Beatty Vinci's preferred logistical transport link, as they reduce the number of vehicle movements interfering with the existing local road network and provide the greatest possible control over works activity.

On completion of the plant crossing, the lights will remain green and will only turn to red when site vehicles are required to cross the road. To further reduce disruption, these lights will be manned during busier periods of the day. Please note that these works are subject to weather conditions.

When these works will take place

A445 Leicester Lane will be closed from **Monday 4 April to Wednesday 20 April** for 24-hours a day, seven days a week including weekends, then between **Thursday 21 April and Friday 29 April**, A445 Leicester Lane will be closed Monday to Friday 9.30am to 3.30pm, and Saturday 8am to 1pm, with temporary traffic lights in operation outside of these hours.

Please note that access will be maintained to all properties during these works.

Two fully signed diversions will be in place, one for local traffic the other for HGV's.

Duration of works

- Works are scheduled from Monday 4 April 2022 to Friday 29 April 2022.
- From Monday 4 April to Wednesday 20 April, the road will be closed for 24-hours, seven days a week including weekends.
- From Thursday 21 April to Friday 29 April, the road will be closed 9.30am-3.30pm on Monday to Friday and 8am-1pm on Saturday.
- Our workforce may be on site one hour before and one hour after to set up and secure our equipment.
- Access to all properties will be maintained during these works.

What to expect

- Some disruption to travel times.
- Two fully signed diversions in place, one for local traffic the other for HGV's.
- Some noise from onsite machinery during working hours.

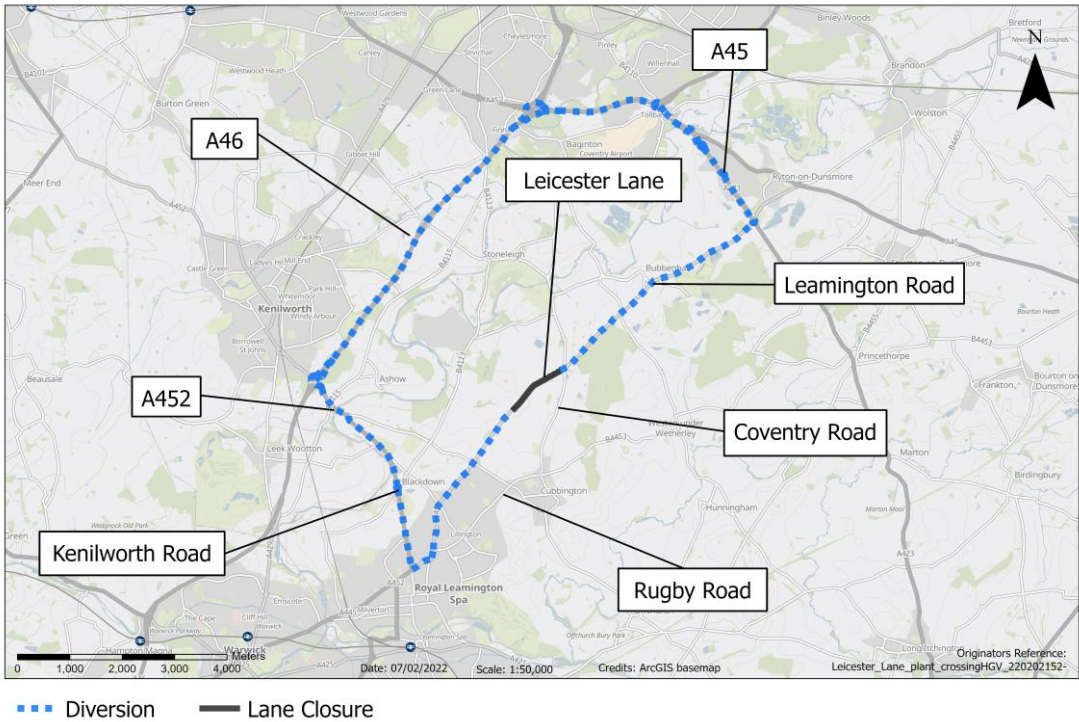

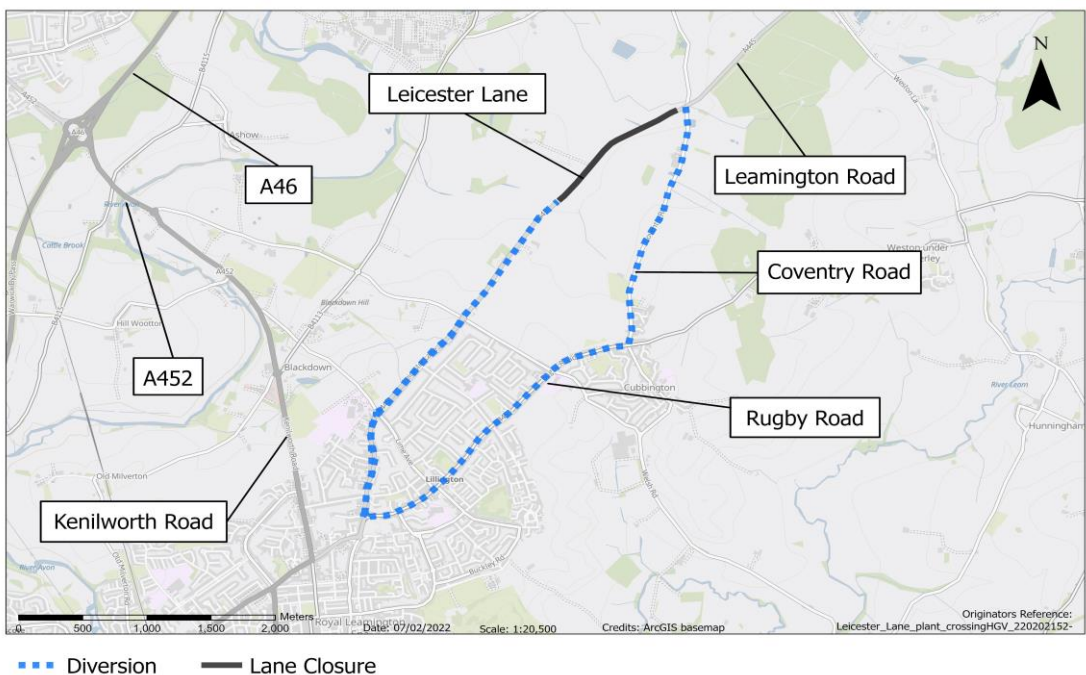
