High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

Full closure of Ridgeway Lane on 31 March 2022 – when and why

As part of our tunnelling activities, we intend to close Ridgeway Lane between 8.00am and 6.00pm on Thursday 31 March 2022. This is to allow us to place a section of a conveyor system over the section of the road network to facilitate the safe transfer of excavated tunnel material from our Long Itchington Wood construction site to a neighbouring section of our works.

This will mean less construction vehicle movements on the road. Ridgeway Lane will also be closed intermittently throughout the day for road users as well as for pedestrians, cyclists and equestrian users.

We apologise for any inconvenience this may cause.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

Installation of a temporary conveyor system to facilitate safe transfer of excavated tunnel material from our Long Itchington Wood construction site to a neighbouring section of our works.
