Wormwood Scrubs micro-tunnelling

A 1.2 m pipe will need to be installed as part of Stamford Brook Sewer diversion to allow for building the Station Box foundations. The location of works is shown on the image overleaf.

To complete this work, we will be using micro-tunnelling. Micro-tunnelling is a digging technique used to construct small tunnels. This work will be completed by using a tunnel boring machine, which will be installed in Wormwood Scrubs and will be driven towards the Station Box on the Old Oak Common Station site. Only a single micro-tunnel will be installed in this part of the Scrubs. This work is needed to allow us to divert the Stamford Brook Sewer.

For safety reasons, the micro-tunnelling works will be 24/7 whilst the tunnels are under construction. This is to avoid the tunnel boring machine being stuck in the ground and causing potential settlement on the surface.

Duration of works

Construction will commence from 18 April 2022 until 2 May 2022. For safety reasons, the micro-tunnelling works will take place 24/7.

What to expect

During the day: Digger movement, concrete lorries, lorries carrying excavated material and tunnelling equipment in operation.

During the night: Crane operation and tunnelling equipment in operation.

What we will do

We will use best practicable means to minimise any impact on our site. Traffic management will also be in place to support this work. Mitigation measures will be in place to reduce the noise level.

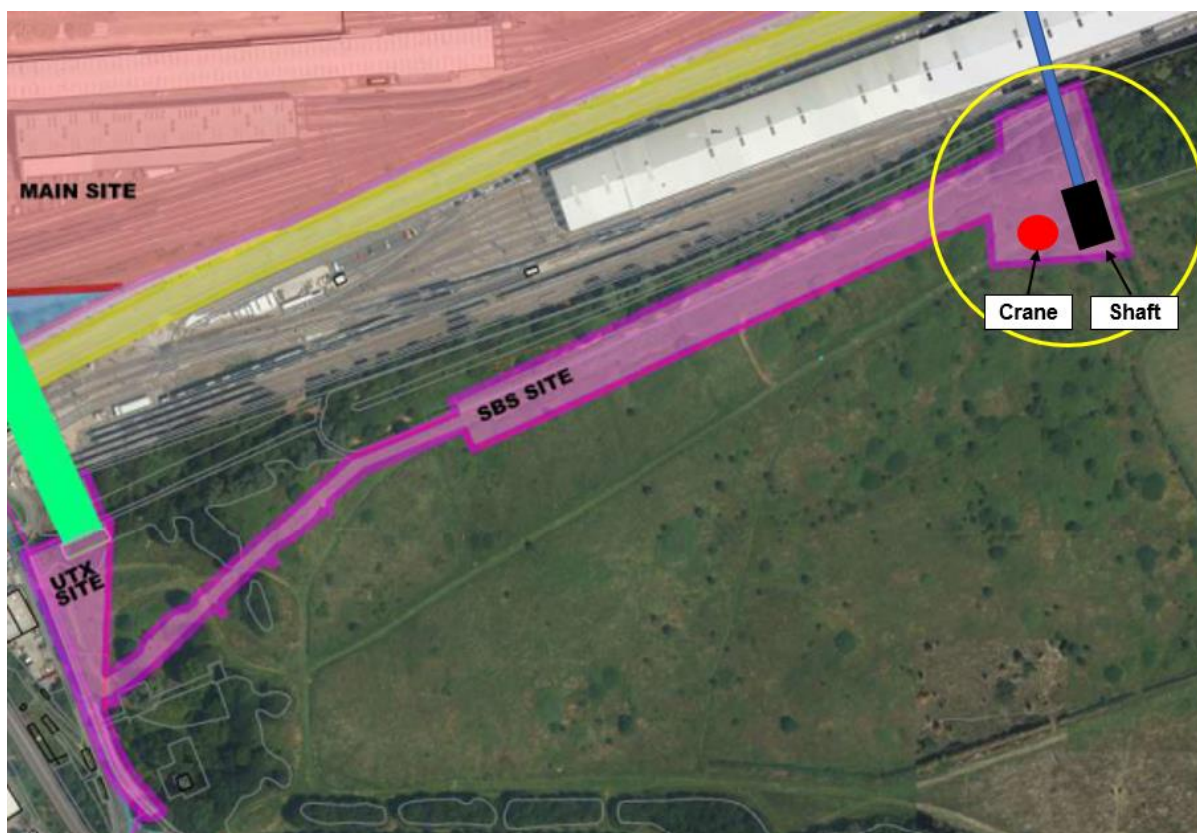

The works will be carried out within the secure compound built in Wormwood Scrubs and no additional vegetation clearance will take place as part of this work. The location of works is shown on the image below.

We will use best practicable means to minimise any impact on our site neighbours by methods such as using noise barriers around the machinery. The concrete lorry and lorries carrying excavated material will only be in use during the normal site working hours between 8am – 6pm Monday to Friday and 8am – 1pm on Saturdays. The excavated material from the micro-tunnelling will be stored in the Wormwood Scrubs compound in skips and will be taken away from site the following day. Access and exit from site will be via the access road constructed on Wormwood Scrubs.

The image below shows the Wormwood Scrubs compound and location of the micro-tunnelling works. The works will be carried out by working inside the shaft.

For safety reasons, the micro-tunnelling works will be 24/7 whilst the tunnels are under construction.
