High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

UPDATE

We previously informed you that temporary traffic lights will be in operation on Waste Lane from Monday 9 May to Friday 13 May. These lights will now be operating the following week from Monday 16 May until Friday 20 May.

The work we will be completing

From Monday 16 May to Friday 20 May, we will be carrying out trial hole excavations in the verge of Waste Lane to identify existing utility services and carry out existing drainage surveys. To carry out these works safely, we will install temporary traffic lights on Waste Lane. The traffic lights will be operational from 9.30am to 3.30pm. Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

- Keep all sites safe and secure


Notice of temporary traffic lights – Waste Lane, Balsall Common
