High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. You can sign up for regular updates in your local area at www.hs2inbucksandox.co.uk.

What are we doing?

As our part of our continued preparatory works, it is necessary to temporarily close a number of Public Rights of Way. In early April, we will be closing local footpaths in Chetwode. This is to ensure the safety of pedestrians as we begin the excavation, movement and storage of earthworks with large plant and machinery.

We are required to fully close footpaths, CHW/11 and CHW/18, for the duration of our works.

When will these works take place?

CHW/11 and CHW/18 will be fully closed, 24 hours a day, from Friday 1 April for approximately three years.

We will work to reopen the footpaths to reduce disruption as soon as possible.

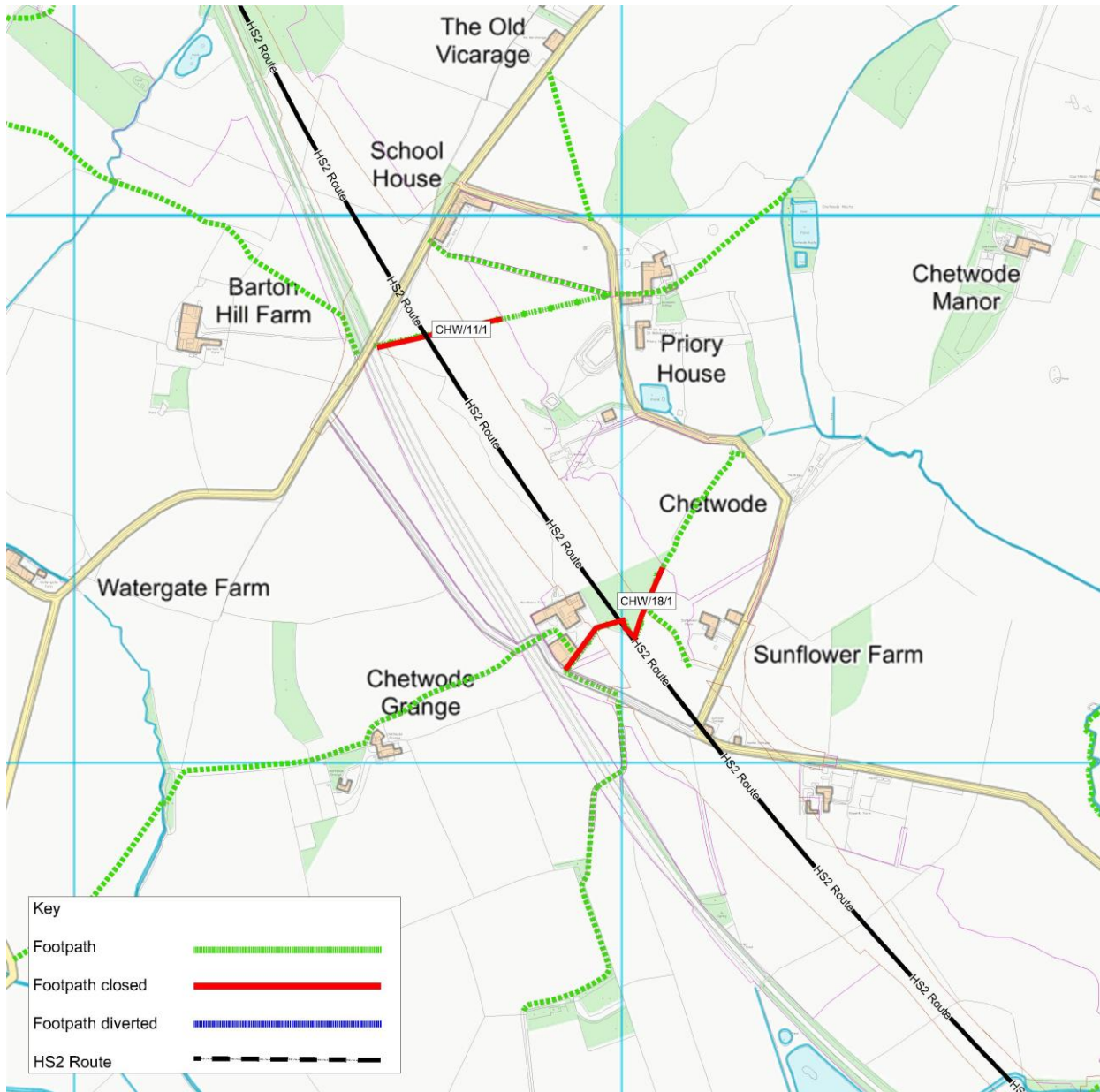
