High Speed Two (HS2) is the new high speed railway for Britain.

We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. #### **Surveys planned in late March**

From 28 March to 1 April 2022, we will be carrying out surveys at various locations in Ealing, Hammersmith & Fulham, and Hillingdon. Our surveyors will work from footpaths or grass verges. They will use equipment mounted on a tripod as shown in the picture on the next page to survey ground levels.

The locations we will survey are listed below:

- Station Road, Willesden Junction, NW10 6TS
- Greenpark Way, Greenford, UB6 0AD
- Greenford Road, Greenford, UB6 0AP
- Mandeville Road, Northolt, UB5 4AA
- Ickenham High Road, West Ruislip, HA4 7DT

#### **About our Community and Business Funds**
