High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be completing

On Monday 21 March we will be closing the link to the A452 at the southern end of Packington Lane along with a small section of Middle Bickenhill Lane that adjoins the link road. This is to safely work on the utilities that are underneath the road in preparation for the construction of the new railway. The closure will last for three weeks starting on Monday 21 March ending on Monday 11 April. Access to business' at Park farm will be maintained but for all other traffic **a diversion route will be in place and is shown overleaf.**

COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. 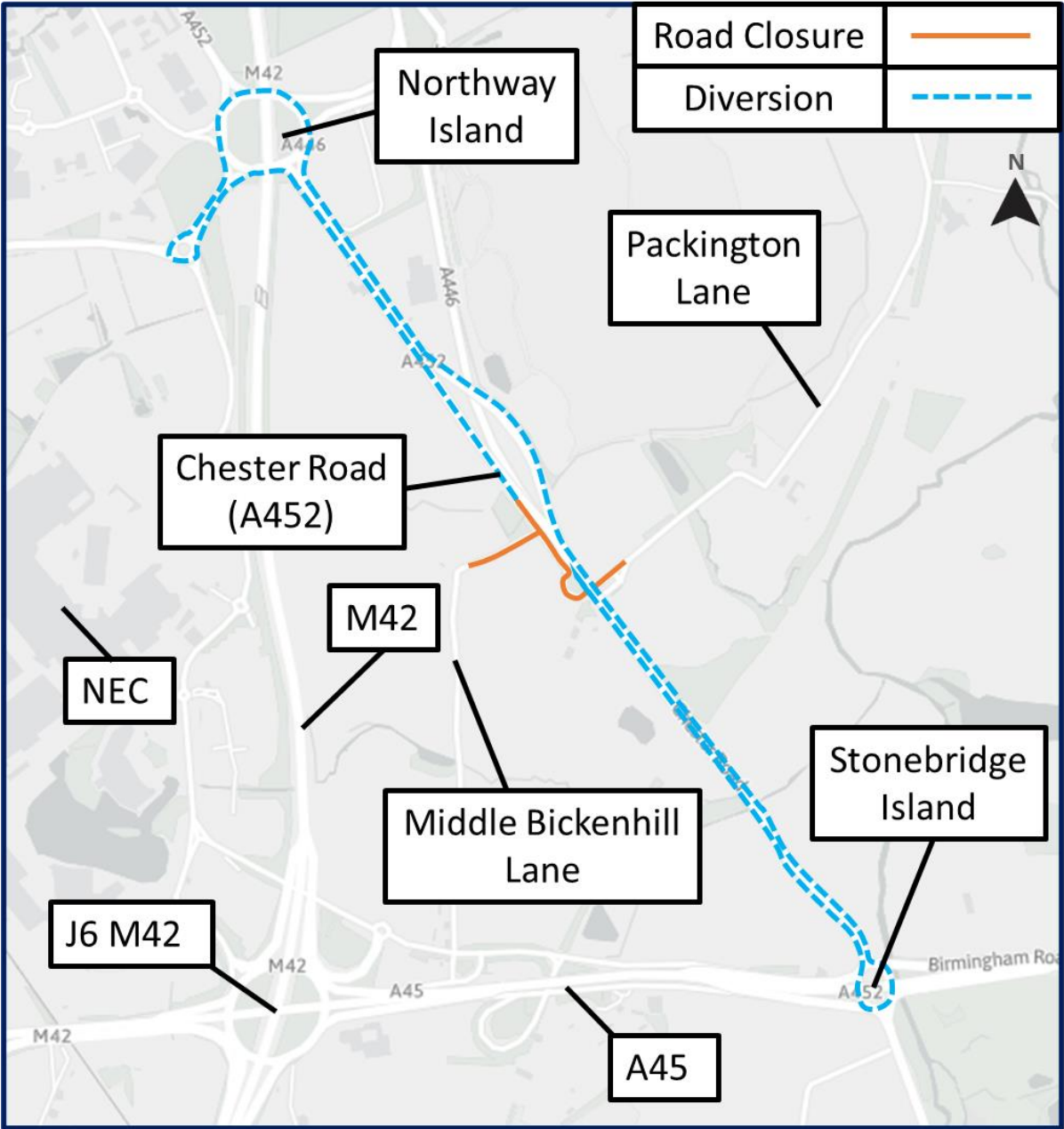
