### Notification of works to the east of A446 Lichfield Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### The work we will be doing

BBV will look to begin works to the east of the A446, to the north of Gorsey Lane. The works set to be complete will be to create a site access into land to the east of the A446, which will be used as our construction access for works in that area.

In order to complete these works, we will need to access and exit site via Gorsey Lane from the A446 and turn left into our working area. We have a maximum of 12 HGV movements in and out of our working area. (Construction route shown in map below).

We will only access Gorsey Lane via the A446 and we will have a road sweeper who will manage the cleanliness of the roads.

Our working hours will be 8am – 6pm Monday to Friday and 8am – 1pm on Saturdays.

#### **HS2 during the COVID-19 pandemic**

We are continually reviewing the works on our construction sites in line with the Government and Public Heath England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. - Access and exit the working area via the A446 and Gorsey Lane

- **HGV** movements from Monday 28 March 2022 until August 2022
- Use of the site access off the A446 to be in use once complete
- Our working hours will be 8am - 6pm Monday to Friday and 8am – 1pm on Saturdays.


