High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

Subject to consents, BBV will complete ground investigation works in areas of Watton Lane, near the A446. Our working hours will be from 9.00pm – 5.00am each night. These works will take place over 6 nights, from Monday 4 April until Saturday 9 April, with the final closure being removed at 5.00am on Sunday 10 April.

In order for us to carry out these works safely we will install a temporary overnight closure on Watton Lane throughout the time of the works. There will be a diversion in place throughout the overnight closures.

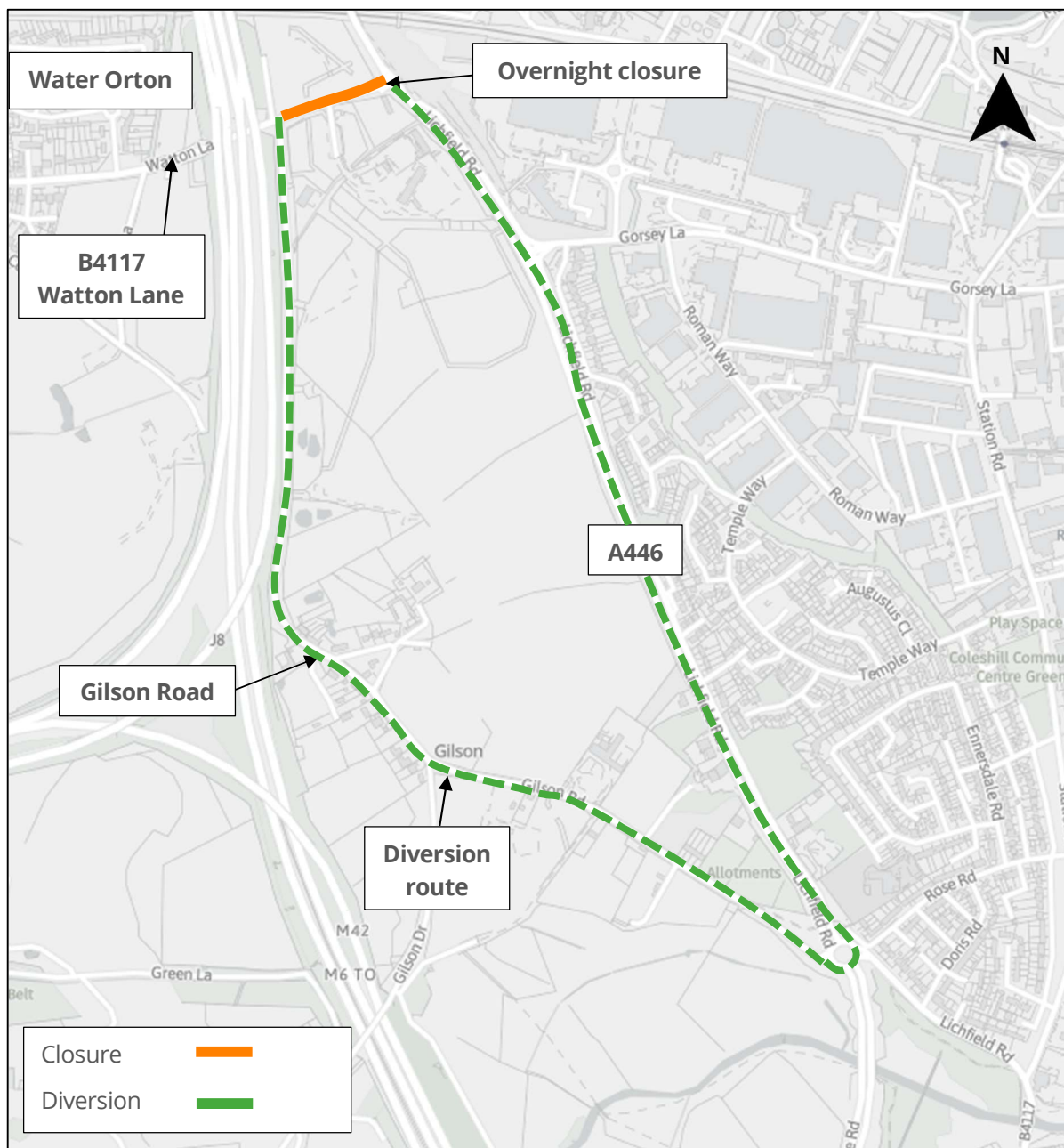
