



Notice of vegetation clearance near Attleboro Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

From Monday 4 April BBV will complete vegetation clearance works in areas near Attleboro Lane to prepare for the construction of the railway line. These works are set to take place for up to 4 weeks. **The indicative area of clearance is shown on the map on page 2.**

Prior to and during the works ecological surveys are complete to ensure that we do not disturb nesting birds in the area. We will access the working area from the B4118 Birmingham Road. As we complete the vegetation clearance, we will install temporary fencing along the clearance areas in order to maintain a secure site. Following this, permanent fencing will be put in place.

From Monday 4 April until Saturday 16 April, we will need to put in traffic management in place as we work near Attleboro Lane. This will consist of a barriered area along where the vegetation clearance will take place, with traffic marshals to allow residents to pass. Works will be paused as any traffic moves past.

Our working hours will be 8.00am – 6.00pm Monday until Friday and 8.00am until 1.00pm Saturdays.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Works are scheduled to start on 4 April 2022 for a 4-week period

What to expect

- Vegetation clearance to take place in areas near Attleboro Lane
- Traffic management from 4 April until 16 April
- Our working hours are 8:00am until 6:00pm Monday to Friday and 8:00am until 1:00pm Saturday.
- Our workforce can be on site 1 hour before and after to set up and take down our work equipment.

- Keep all sites safe and secure.

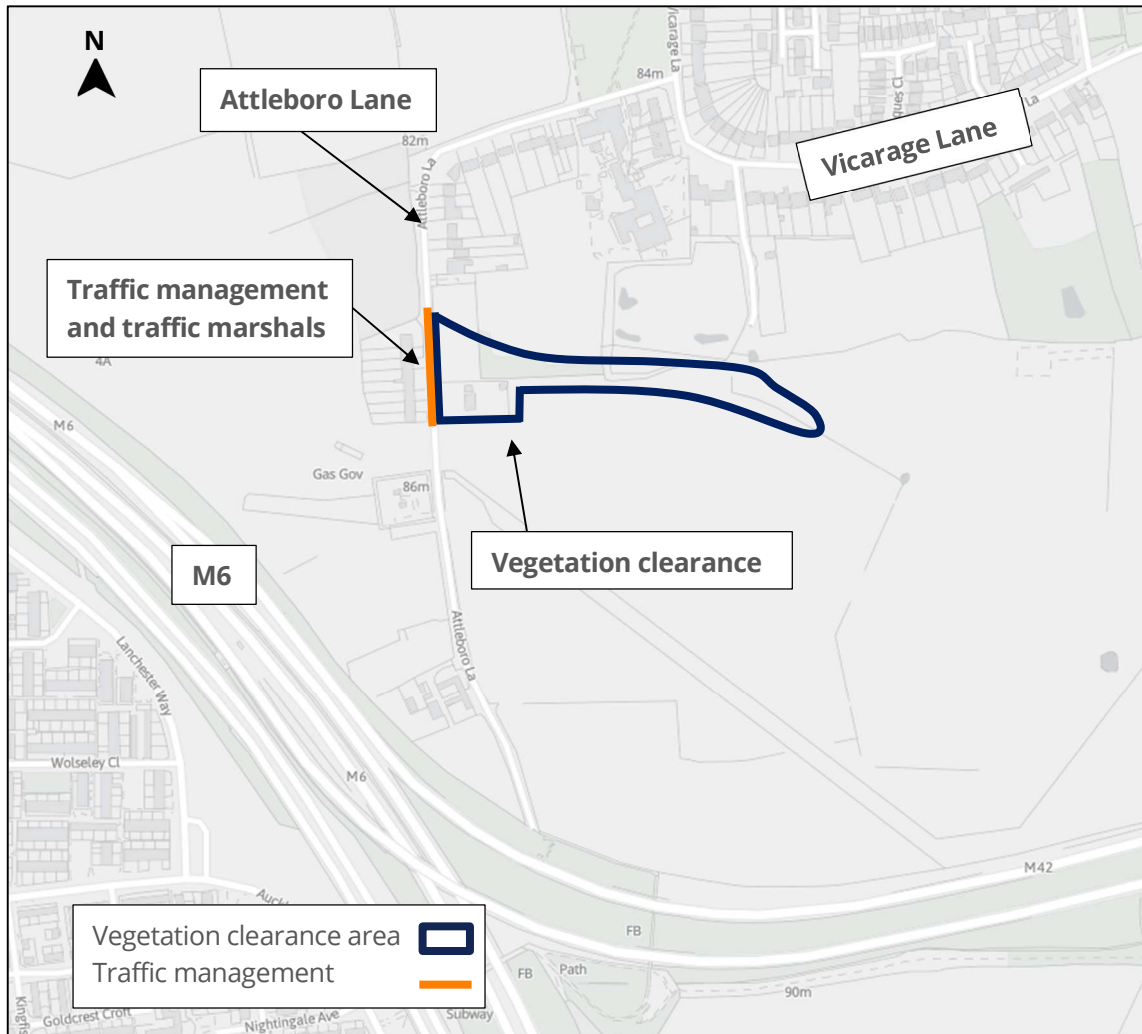

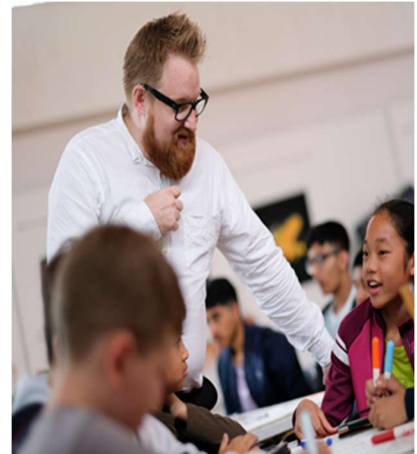
About our Community and Business Funds
