

# Notice of temporary lane closure on the A452 Kenilworth Road, Hampton-in-Arden

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons. This notification replaces a previous one, distributed to local communities regarding this lane closure taking place in April. The closure planned for 4 April did not take place.

### **Temporary southbound lane closure**

In order to prepare for the future construction of the HS2 railway, we will be carrying out vegetation clearance along a short section of the A452, Kenilworth Road. To conduct this work safely, we need to temporarily close a single lane on the A452 dual carriageway, southbound.

The lane closure will be in place from **Tuesday 10 May to Tuesday 17 May** between **09:30 am and 3:30 pm**. Our teams will be on-site one hour before and one hour after the work to set up and secure the site at the end of each day.

Access to properties and businesses will be maintained. Please see the map overleaf for more information.

#### **HS2** and the COVID-19 outbreak

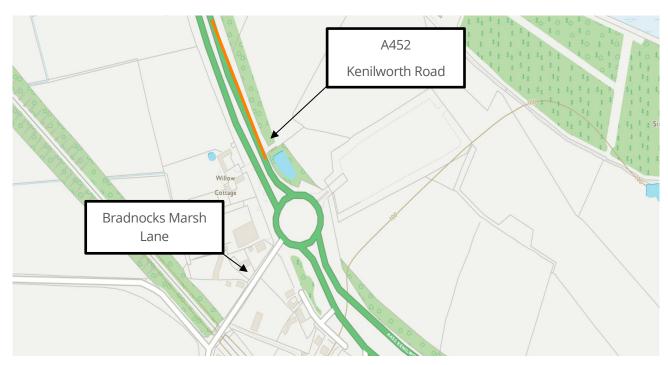
# Location of temporary southbound lane closure
