This forward look covers HS2 associated work in Staffordshire.


The document is a forward look of construction activities planned in the next three months.


### **Map 1 - Fradley and Handsacre**



Location of works	Proposed duration	Description of works
Location 1	From Spring 2022	<ul> <li>We will create a working area and compound on land off the A515. This will include:</li> <li>Deliveries of materials and equipment to site</li> <li>Installation of temporary fencing</li> <li>Construction of a satellite compound with welfare facilities for staff</li> <li>Investigating ground conditions, including ground penetrating radar (GPR) surveys</li> <li>Removal and storage of topsoil within the work area</li> </ul>

		Delivery of some environmental & ecological mitigations and removal of some existing vegetation.  We will also be constructing access tracks and a haul road at this location, from the A515 South towards Ravenshaw Wood and from the A515 North through Bourne Brook to Shaw Lane.  Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site.
	Ongoing throughout 2022	We will also complete corridor preparation works such as vegetation clearance.
Location 2	Spring 2022	<ul> <li>We will create a working area and compound on land off Wood End Lane. This will include:</li> <li>Site surveys</li> <li>Deliveries of materials and equipment to site</li> <li>Construction of a satellite compound with welfare facilities for staff</li> <li>Installation of temporary fencing</li> <li>Removal and storage of topsoil within the work area</li> <li>Utility diversion works in place</li> <li>Construction of haul roads and accesses.</li> </ul>
Area-wide	Spring 2022	We will undertake a range of surveys in this area, including utility, environmental and ground investigation surveys, that may require temporary traffic management. Our activity will include:  • Excavating 'trial holes'  • Ground Penetrating Radar (GPR) surveys to help locate existing utilities  • Surveys to check existing ground levels  • Surveys of water bodies  • Ecological surveys.


## Map 2 - Whittington to Fradley



Location of works	Proposed duration	Description of works
Location 1	Ongoing throughout 2022	<ul> <li>Over this period, we will continue to use the slip-road off the A38 for the transportation and stockpiling of materials at the compound</li> </ul>
		We will use the access and haul road at this location to create a working area to enable us to commence pilling works. To support the completion of these works, we will install monitoring equipment and undertake vegetation clearance
	Ongoing throughout 2022	Continuing pilling works for the preparation of the West Coast Mainline overbridge. Work will also include: earthworks, drainage, installation of structures. This may also include some overnight closures of the West Coast Mainline at this location.

Area-wide	Ongoing throughout 2022	We will undertake a range of surveys in this area, including utility, environmental and ground investigation surveys, that may require temporary traffic management. Our activity will include:  • Excavating 'trial holes' • Ground Penetrating Radar (GPR) surveys to help locate existing utilities • Surveys to check existing ground levels • Surveys of water bodies • Archaeological investigations • Ecological surveys.



Location of works	Proposed duration	Description of works
Location 1	Ongoing throughout 2022	<ul> <li>We will continue creating a working area and compound on land off the A5. This will include:</li> <li>Deliveries of materials and equipment to site</li> <li>Installation of temporary fencing</li> <li>Construction of a satellite compound with welfare facilities for staff</li> <li>Investigating ground conditions, including ground penetrating radar (GPR) surveys</li> <li>Removal and storage of topsoil within the work area</li> </ul>

		<ul> <li>Delivery of some environmental &amp; ecological mitigations and removal of some existing vegetation.</li> <li>Work at Buckshead Farm undertaking property demolitions which will also include a PRoW diversion.</li> <li>Traffic management on the A5;</li> <li>Four nights of overnight closures to install speed cameras</li> <li>Single lane traffic management during bridge construction.</li> </ul>
Location 2	Ongoing throughout 2022	We will continue works at our Whittington compound, constructing a haul route and undertaking early earthworks.
Area-wide	Ongoing throughout 2022	We will undertake a range of surveys in this area, including utility, environmental and ground investigation surveys, that may require temporary traffic management. Our activity will include:  • Excavating 'trial holes' • Ground Penetrating Radar (GPR) surveys to help locate existing utilities • Surveys to check existing ground levels • Surveys of water bodies • Ecological surveys • Demolition of properties.

Location of works	Proposed duration	Description of works
Location 1	Ongoing from Spring 2022	<ul> <li>Using the existing HS2 access off the A453 Sutton Road, our activity will include:</li> <li>Deliveries of materials and equipment to site</li> <li>Construction of haul road and a satellite compound with welfare facilities for staff</li> <li>Investigating ground conditions, including ground penetrating radar (GPR) surveys</li> <li>Removal and storage of topsoil within the work area.</li> <li>We will also be constructing a haul road at this location.</li> </ul>

Location 2	Ongoing from Spring 2022	<ul> <li>Our activity will include:</li> <li>Creating an access from the highway to our working area</li> <li>Deliveries of materials and equipment to site</li> <li>Investigating ground conditions, including ground penetrating radar (GPR) surveys</li> <li>Removal and storage of topsoil within the work area.</li> <li>We will also be constructing a haul road at this location.</li> </ul>
Location 3	Ongoing from Spring 2022	We will continue further archaeological investigation.
Area-wide	Ongoing throughout 2022	We will undertake a range of surveys in this area, including utility, environmental and ground investigation surveys, that may require temporary traffic management. Our activity will include:  • Excavating 'trial holes' • Ground Penetrating Radar (GPR) surveys to help locate existing utilities • Surveys to check existing ground levels • Surveys of water bodies • Archaeological investigations • Ecological surveys.

# **Our Community Commitments**

Our aspiration is to be a good neighbour every single day, by respecting the people and communities we impact and being sensitive to their needs, earning our social licence to operate.

#### We will:

- 1. Continue to build respectful, long-term relationships with communities and actively encourage our workforce to listen to local concerns and be considerate and accountable for their actions at all times.
- **2.** Work with communities to develop local two-way engagement and communication programmes, ensuring they are accessible and tailored to local needs.
- **3.** Make sure communities are made aware in advance of any activities taking place in their area.
- **4.** Operate a Freephone Community Helpline 24 hours a day, 365 days a year.
- **5.** Make health and safety a priority for communities and our workforce.
- **6.** Respect the wellbeing of communities, minimising disruption to their lives with local mitigation plans and activities, ensuring we meet the standards set out in the Code of Construction Practice.
- 7. Leave a positive and sustainable legacy for the communities in which we operate.
- **8.** Respond to questions and complaints quickly and efficiently, with an acknowledgement within two working days, and responding within a maximum of 20 working days if we cannot answer the query straight away.
- **9.** Promote awareness of all our property schemes so that anyone who may be eligible has all the information they need and is aware of the support available to them.
- **10.** Display the Residents' Commissioner and Construction Commissioner's contact details on all relevant materials, along with the HS2 Helpline information and complaints procedure.

The Code of Construction Practice forms part of the Secretary of State's Environmental Minimum Requirements for the construction of the railway from London to the West Midlands. It sets out the standards and responsibilities to protect communities and the environment during construction.
