## The work will we be doing

We will be closing the Stoneleigh Road for emergency works to remove four trees damaged in recent storms. This is to prevent any further damage and fallen trees in the future.

## When these works will take place

To allow us to carry out these works safely we will be closing Stoneleigh Road on **Thursday 10 March and Friday 11 March** between **9.30am and 3.30pm**.

Access will be maintained to all properties while these works are being carried out.

Please note, these works coincide with the current 24-hour closure on Stareton Lane, due to end on 11 March.


