September 2022

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Update.

We previously contacted you to advise that we will be installing temporary traffic lights on Meriden Road while we make improvements to the road surface by installing what is known as a 'plant crossing'. Plant crossings allow our heavy machinery to cross the road without causing damage to the highway.

For the safe operation of the plant crossing, the speed limit is being reduced from 50 miles per hour down to 30 miles per hour. These restrictions will be in place from 22 September 2022 for an initial period of 18 months. The speed limit will be in force all day everyday during that period


