

Three-month look ahead

Location of works	Proposed duration	Description of works
Location 1 Warwickshire border	July 2021 to January 2022	Archaeological mitigation south of Banbury Road, including topsoil excavations and hand digging which will uncover areas containing significant archaeology.
	January to February 2022	Highway reinforcement work will take place on Wormleighton Road, in preparation for a construction vehicle crossing point and the site access road.
Location 2 Lower Boddington	November 2021 to April 2022	 Further ground investigation works and localised vegetation clearance; and Construction of internal construction haul and access roads near Lower Boddington.
	November 2021 to June 2022	 Completion of a temporary access bridge at Highfurlong Brook; Continuation of main earthworks activities including stockpiling of materials; Preparation works for Highfurlong Viaduct; and Creation of water management ponds.
Location 3 Aston Le Walls	November 2021 to April 2022	Earthworks and preparatory work for construction of the Chipping Warden Green Tunnel.
Location 4 Chipping Warden	Ongoing to February 2022	 Construction of the office and welfare facilities at Chipping Warden Compound; and Construction of the concrete batching plant.

Location 1 Blackgrounds	Ongoing to February 2022	Excavation and translocation of a marsh land.
	January to March 2022	Temporary diversion of several public rights of way near Culworth Road, Chipping Warden.

Location 2 Thorpe Mandeville	December 2021 November 2021	Building of new bat houses for ecological mitigation. • Construction of the office, welfare and parking

		Construction of a concrete batching plant; and
		Construction of a construction vehicle crossing area on Banbury Lane and Banbury Road near Thorpe Mandeville.
Location 3 Greatworth Park	December 2021 to March 2022	Site preparations for the construction of a temporary road between Sulgrave Road and the B4525 Welsh Road, known as the 'Greatworth T';
		 Further construction of internal construction roads;
		Closures and diversions of some local footpaths; and
		Further excavation, removal and storage of earth in preparation for the Greatworth Green Tunnel.
	January 2022	Archaeological mitigation including topsoil excavations and hand digging.

Location 1 Halse Copse	December 2021	Important hedgerow translocation.
Location 2 Radstone	November 2021 to January 2022	 Creation of a temporary compound for access; and Earthworks including temporary settlement ponds, site access roads and earth bunds.

Location 3 A43	October 2021 to January 2022	Archaeological mitigation including topsoil excavations and hand digging.
	November 2021 to February 2022	Earthworks including temporary settlement ponds, site access roads and earth bunds;
		 Continued set up of the A43 Compound including topsoil stripping and creation of the temporary access;
		 Creation of the new Radstone Road junction from the A43, including a two-month road closure and A43 northbound narrow lanes;
		Demolition of property (Iletts Farm); and
		 Forming site access roads and haul roads north of the A43 towards Radstone.
Location 4 A422	November 2021 to February 2022	 Continued set up of the A422 compound next to the A422 Brackley Road;

Our commitments to you

Informing

- We will tell you about HS2 works in your area.
- We have local community websites and newsletters with regular information and updates about our work in your area.
- We have local community teams who know your area. They will hold local events and run projects to keep you informed.

Involving

- We will involve you in opportunities to benefit and learn as we build HS2 including jobs, skills, education, employment and funding.
- We will ask you about the design of specific parts of the railway.

Responding

- Our dedicated HS2 Helpdesk is available 24 hours a day, every day of the year, to help with any questions or concerns you have about HS2 or our work.
- If things go wrong, we have a complaints process and a dedicated complaints team.
- An independent Construction Commissioner monitors how we manage and deal with complaints.

Consulting

- We will hold formal consultations with you while we seek permission to build Phase 2b of HS2.
- We now have permission to build Phase One and Phase 2a. This means we will only formally consult on this part of HS2 when we need permission to do things that fall outside the terms of the legislation agreed by Parliament.

Keeping you informed

We are committed to keeping you informed about work on HS2. This includes ensuring you know what to expect and when to expect it, as well as how we can help.
