



Update: date change to Overnight road closure on Victoria Road

High Speed Two (HS2) is the new high speed railway for Britain.

Rescheduled overnight road closure on Victoria Road to install conveyor crossings

We wrote to you in March 2022 regarding an overnight road closure on Victoria Road between School Road and the Boden building to install two conveyor crossings over the road.

These works were due to take place overnight between 10pm on Friday 15 April to 6am Saturday 16 April. Due to unforeseen circumstances relating to the delivery of components of the conveyor structure, these works have now been rescheduled to take place overnight between **10pm Saturday 23 April to 6am Sunday 24 April**. If these works cannot take place overnight on the 23 April, we will aim to carry them out overnight on the 24 April between 10pm and 6am.

Temporary Road changes during the installation

During these works a full road closure will be in place on Victoria Road between School Road and the Boden building. Access to Boden will be maintained during these works.

A vehicle and pedestrian diversion will be clearly signed. A map and further details of the works can be viewed online on the previous notification at <https://www.hs2.org.uk/work-items/overnight-road-closures-on-victoria-road/>

During the works, we will lift the two conveyor crossings into place. Each lift will last up to one hour. For safety reasons during the lifting operations, there will be no pedestrian access on Victoria Road between School Road and the Boden building. We will also have traffic marshals in the area to assist pedestrians.

The date for these works may change. We will keep you updated about any further changes.

Overnight on Saturday 23 April from 10pm to 6am the following morning with a contingency the following night

We may be on site for an hour before the start and/or end of the shift

Full road closure on Victoria Road between School Road and the Boden building

Full footpath closure on Victoria Road between School Road and the Boden building during the lifting operations

Vehicle and pedestrian diversions will be in place

You may notice some additional noise and light during installation of the crossings
