



# Notice of road closure – A45 service road and East Way

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working on behalf of HS2 Ltd to build the new high speed railway in your area.

## What work will we be completing

We will be removing the existing temporary safety barriers along the slip roads to reinstate a power connection. This is in preparation for the construction of a railway bridge over the A45.

## When will the work take place

The works will take place over a two day period starting from **9pm on Friday 8 April until 9pm on Sunday 10 April 2022**

To complete our works in a safe environment, we will be implementing a full road closure to the slip road connecting A45 and East Way.

If the work is completed early, we will remove the closure.

## HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. - Keep all sites safe and secure.

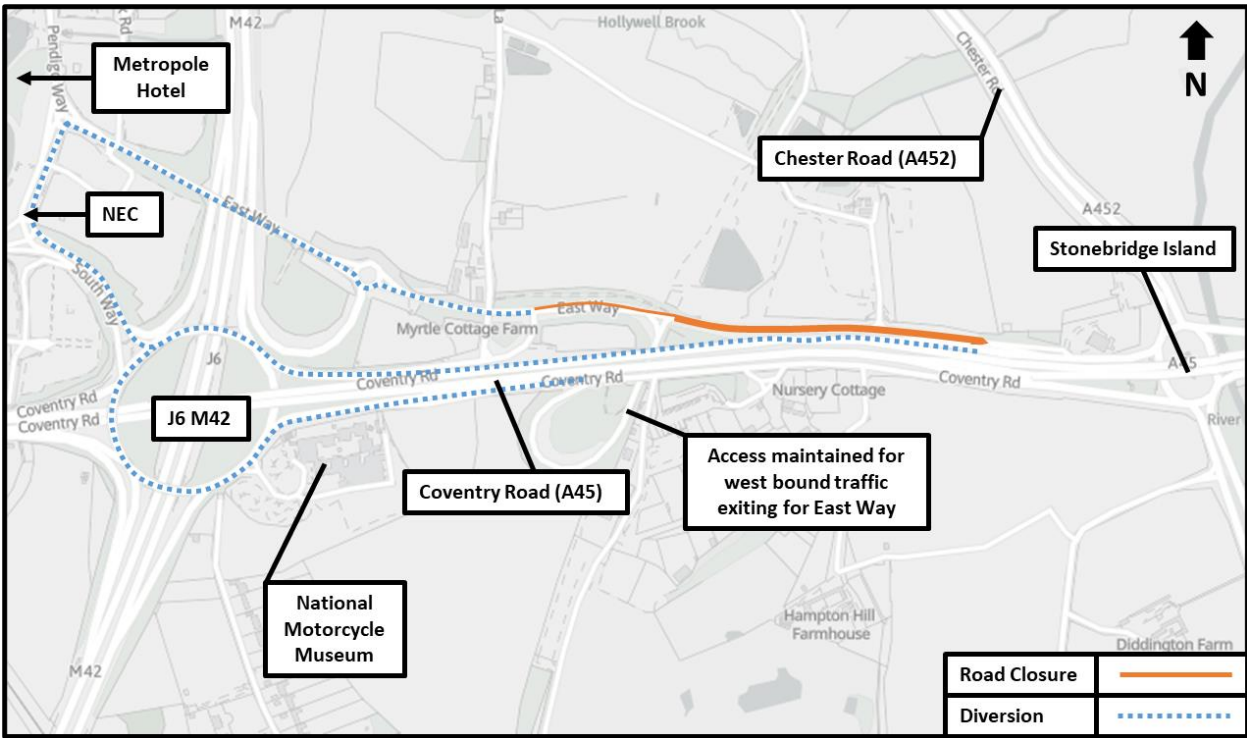
