What we are doing

We will be carrying out laser scanning surveys of the bridges in Greenford Road and Lyon Way. The surveys are non-intrusive and will provide us with information on the condition of the bridges ahead of the launch of the Tunnel Boring Machines (TBM) at the West Ruislip portal.

The surveys are scheduled to take place overnight from Monday 9 to Friday 13 May 2022, 8pm to 5am to minimise disruption.

To ensure the works can be carried out safely, our survey team will be working within the carriageway under the bridges utilising a lane closure at each location, for the duration of these works.

How these works might affect you

Temporary traffic management of a lane closure and footpath closure will be installed on Greenford Road from 9 to 11 May between 8pm and 5am. There will also be a lane closure on Lyon Way from 11 to 13 May between 8pm and 5am. In order to fully scan the width and length of the bridges, the lane closures will be alternated on each side of the road.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum
